Approval of Minutes – October 25, 2021 APPROVED

Public Hearings:

35 Woodin Road Subdivision, 35 Woodin Rd – Minor Subdivision (21.145)

APPROVED. Board held a Public Hearing and approved the two-lot subdivision for purposes of constructing a single-family home.

Troy Top Soil Subdivision, Lower Newtown, Upper Newtown & Hudson River Rd - Minor Subdivision (21.167)

APPROVED. Board held a Public Hearing and approved the subdivision to create four (4) lots from three (3) existing lots.
