## Event Waiver and Release: Big Balls Adventure Zorbing

In consideration of being permitted to utilize the facilities, services and programs of Big Balls Adventure Zorbing (or for my children to so participate) for any purpose, including, but not limited to observation or use of facilities or equipment, or participation in program, the undersigned, for himself or herself and such participating children and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the facility for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation by the undersigned and such children. The undersigned is aware of the different types of activities, equipment, and facilities offered by the organization, and is aware of the risks inherent in the participation in such activities and use of such equipment and facilities. In further consideration of being permitted to enter the facility for any purpose including, but not limited to observation or use of facilities or equipment, or participation in any program affiliated with the organization, the undersigned hereby agrees to the following:

1. The undersigned on his or her behalf and behalf of such children, hereby releases, waives, discharges and covenants not to sue Big Balls Zorbing, its directors, officers, employees, and agents (hereinafter referred to as "releases") from all liability to the undersigned or such children and all his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefor on account of injury to the person or property or resulting in death of the undersigned or such children whether caused by the negligence of the releases or otherwise while the undersigned or such children is in, upon, or about the premises

or any facilities or equipment therein or participating in any program affiliated with Big Balls Zorbing.

2. The undersigned hereby agrees to indemnify and save and hold harmless the releases and each of them from any, loss, liability, damage or cost they may, incur due to the presence of the undersigned or such children in, upon or about the premises or in any way observing or using any facilities or equipment of the organization or participating in any program whether caused by the negligence of the releases or otherwise.

3. The undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage to the undersigned or such children due to negligence of releases or otherwise while in, about or upon the premises and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with Big Balls Zorbing. The undersigned further expressly agrees that the foregoing release waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of State and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

### **RULES: I UNDERSTAND THE FOLLOWING...**

1. Do not run into someone if the ask you not to, are facing a different direction, are much smaller than you or are on the ground, trying to get up.

2. Referees have the final say in the arena. After 1 warning, a staff member is allowed to ask you to take a 10 minute break from playtime. If there is another incident, you will be removed from the arena for the remainder of the day. If there are multiple incidents, on multiple days, you will be banned for good.

3. Do not run full speed into the arena walls. It is not meant to support that much force. The walls are only designed to protect you should you bounce off another player.

4. You must be inside a ball to be in the arena. Parents and players must stand outside the arena when not playing inside a ball. It is for your own safety.

5. Play safely and have fun!

6. There are no refunds on games and hourly rates.
