LEGAL NOTICE OF PUBLIC HEARING ON THE BUDGET

A PUBLIC HEARING on the Proposed 2016 District Budget for the Halfmoon Fire District #1 (Hillcrest) will be held at 7:00 P.M. at the Hillcrest Fire Station, 145 Pruyin Hill Road, Mechanicville, New York 12118, in the Town of Halfmoon, State of New York on Tuesday, the 20th day of October, 2015.
