

Assistance in Visualizing Proposed Project Limits


Dear Mr. Hallock:

Thank you for your October 9, 2015 response to my September 16, 2015 letter regarding the Operation and Expansion of the Colonie Landfill. As you are aware, we have been following The Town of Colonie request to NYSDEC to expand the size of the Landfill to allow for its operation for another 20+ years.

Based on the information presented at the recent Community Information Meetings and the information contained in the pre-DEIS that has been published on your web site, our residents and the community, in general, are having a difficult time visualizing the limits of the build out of the proposed expansion. In an effort to assist in the understanding of the proposed limits, I would like to propose the placement of large balloons (possibly red or orange weather balloons) around the entire site with their elevations matching the elevations of the final build contours. This would provide the community with a comprehensive visual reference of the finished project, and provide a method for the Town and its neighbors to accurately evaluate the visual impacts.

I would be happy to meet with you to discuss this proposal and assist in determining the placement of the balloons to best represent the finished limits. Thank you in advance for your assistance in providing the means for the surrounding communities to gain a better understanding of your proposed project.
