So we are fixing the fact that that was mistakenly taken out of our local laws when we switched to E-Code. You can thank John Cooper for being in my ear constantly to get this done. The Board members have been very supportive in helping me review the language because it may surprise you but I am not as professional when it comes to responding to false alarms. The local law also requires that the people who own the buildings leave contact information for individuals who will be required to go to the scene to help you guys in case there is any issue with regards to getting into the building and accessing whatever you need and not break down doors etc. That is the summary of the local law.

Supervisor Tollisen asked if there were any questions or comments of the Board

Councilman Connors: I just have one thing to add to that. Being a former Fire Chief and a neighbor to West crescent, millions of dollars of equipment go out on the road for these false alarms. Every minute and hour that they are on the road can cause an incident. This is definitely a huge step to alleviate that issue and that is a complement to the Building and Code Department for recognizing that.

Supervisor Tollisen: I wanted to mention that those to the left of me and myself all went to the Association of Towns training School in NYC and attended a number of good meetings and brought back many positive things for the town.

Second thing; we have discussed the 2018 end of year budget and what we are projecting is that it looks like the town's General Fund will have a surplus of \$750,000. The Water Fund will also have a rather large surplus and the Highway Fund will have about an \$180,000 surplus. What that means is basically our expenditures were less than our revenues, which is always a positive thing.

When I started in office 5 years ago, the General Fund, fund balance was about \$70,000 and now that number is about \$4,000,000, so overall the town is financially improving and making some great strides. You see that we are doing some different things in town like the Splash Pad, the Dog Park, the Veterans Memorial; we have laid miles and miles of water lines and provided more infrastructure. All of those things were either paid for by grants or by cash and NO public borrowing. The town is on a great path! I will get more details on the state of the town in the next couple of months when 2018 is finally closed. You may be wondering why it is not closed when 2018 is over, but we are still waiting for last minute bills that need to be paid. We need to pay those before we can finalize the budget for 2018.

The State has changed the rules so now we have to purchase the vehicle and they will reimburse us a monthly amount once we certify that they are being used for senior purposes. So while we spent money on purchasing a brand new van, at the end of the day, the town will get reimbursed about \$15,000. All in all, it's a very good program.

Councilman Hotaling: I just want to make a comment on that. Some of these vans have between 160,000 and 180,000 miles on them and we do get our monies out of them. The Highway Garage does a great job with the maintenance on them and we have great staff that drives the seniors to their appointments and delivering them hot meals.
