If you work for the Town of Halfmoon, stand up, all the Senior Van & scheduler come up and see Ray for a second. This is our Team with Lynda as the Boss. The Fire Department, all family and friends and the folks from Umpiring, please stand. We appreciate all of you guys for coming here tonight.

Supervisor Tollisen: We are happy to have Senator Tedisco here with us tonight to say a few words.

Senator Tedesco: I am happy to be here tonight with Ray, you and your family and friends, outstanding government officials, your fellow loved ones, fire fighters, we really could use you in the Senate as we could use somebody to call balls and strikes! You'd be a great umpire there! I was thinking while reading your life story. I won't go into the great service you provided while in the U.S. Coast Guard which is impressive. So, all those things added up, you certainly are a Halfmoon Hero! I am honored to say that I had the opportunity to be the Senator to represent you and represent Halfmoon in the 44th Senatorial District. We can't thank you enough and I have a NYS Citation to present to you and commemorate this day in remembrance of everything you've done for this wonderful community. And the place that I like to say all good things emanate from. Thank you so much. Thank you to your lovely family and thank you to the supporters and loved ones you have and the great governmental leaders who serve you here. Thank you for having me.

Assemblywoman Walsh: It's always hard to follow Senator Tedesco as he always says everything that I was about to say. I am just honored to be here today to join you. I was glad to hear about this today and came up from Albany after a long day to Halfmoon for this. I represent ten towns which is about 130,000 people and travel a lot and what I find is that the core group of individuals in each town seem to carry it for the whole town, and you are one of those people Ray. I have met you from the Senior picnics and from driving that van and that was a rowdy van. I know some of the people on that van!

From the Audience: You aren't one of the Dollies, are you?

Assemblywoman Walsh: I don't know. He's not telling! I was dancing, I know that! But seriously, there is a core group of people who do so much for the community and you Ray are one of those people! I think that the whole Halfmoon Hero program is outstanding. I think that the people who do the most, don't do for the citation that I am going to be handing you or the recognition, you wake up with a grateful heart and you want to give of yourself to others. Thank you for doing that for all of those years in all these different capacities. You are a very busy man! I just want to say thank you for all of things that you have done for Halfmoon for everybody here and I am honored to be here on behalf of U.S. Senate to present you with this citation.

Each of these projects is going to be funded through the town's Capital Reserve Funds and therefore the is going to be no increase to the individual user costs for these improvements.

Councilman Wasielewski: Carrie, on the first one, the Route 9 one, and I am not an expert on this, would it make sense to cross over Route 9 by Stone Quarry and go up the east side of Route 9 rather than go up by the plumbing supply place?

Carrie Dooley: I think the idea was to have the shortest run of pipe to make that interconnection. If we came all the way to Stone Quarry, obviously that is more length of pipe and increases the cost of the project.

Councilman Wasielewski: Gotcha. Thanks.

A resolution is necessary to create the project budgetary accounts within the Capital Projects Fund for the Brigantine Drive Water Main Replacement. The existing main was constructed in the 1980's and has experienced numerous water main breaks resulting in repeated disruptions in service. To improve reliability of water service and increase longevity of the water system, the existing water main will be replaced with approximately 575 linear feet of 8-inch high-density polyethylene (HDPE) pipe. New 1-inch water services will also be installed from the new main to the property line and reconnected to the existing services that serve the residential units.
