Supervisor Tollisen: Congratulations Judge Ciulla.

Judge John Ciulla: Just briefly, because I know that you have a lot of other business. Those of you, who know me, know that this kind of thing for me, I frown upon and try to get out of it. When Lyn approached me, I said," No Lyn, I am going to Florida!" Then I put off returning phone calls for 3-4 days and then I decided I to make the phone call and try to talk them out of it. Finally, I became willing to come up here and get the resolution. Tonight, I am going out the door and my wife gives me the look and says "No jacket?" You know everybody talks all the time about what part of retirement do I not understand. I understood the part about not having to wear a jacket anymore.

Seriously, I need to thank the Town Board, you Supervisor Tollisen for giving me this opportunity to serve directly, the residents of Halfmoon. For the years I was in the Public Defender's Office, I served you indirectly via a number of your constituents in your town courts, but this gave me an opportunity to serve you directly. Linda and I have now lived in the town for over 25 years. I thank you for giving me the opportunity. I also want to thank publically, the people that you have in the court and the staff in the court. They are excellent, excellent people. On Supervisor Tollisen's and my side, you have Chris and Jackie. They went out of their way to make sure I knew what I was doing and kept me out of trouble and made sure everything was fine. On Judge Wormuth's side with Marlene and Kathy were outstanding in helping me and I want to thank all of them.

I especially want to thank Judge Wormuth, because he was the one that took the late night phone calls when I did not quite know what I was doing, how do I handle this, how do I handle that. He never once ever refused to answer the calls, so I thank him too. And I thank all of you for giving me this opportunity.

Supervisor Tollisen: It is true Judge Ciulla did try to get out of it. That is why it is the April meeting that we are doing this

Councilman Polak: Just like a judge, gives you the sentence and rushes to his chambers.

PRESENTATION - HALFMOON HISTORICAL SOCIETY

James Bold, President of the Halfmoon Historical Society, Judge Ciulla walked out before I could get in my comment that you can see I do not have a tie or a jacket. I did not get the look.

What we are going to do here this evening is to give you an overview of the things that the Halfmoon Historical Society has been engaged in over the past two years. We will skip across the top and try to keep it to a minimum, because if I tried to explain everything in the last two years, that would take a very long time. Each of you has in front of you a copy of two newsletters. In 2012 we did 3 newsletters and you have a copy of one. In 2013, we did one letter and you have a copy of that. What I will be addressing some of the highlights of those.

Some of the things we did in 2012: One major effort had to do with an open house in May. Our members were all dressed in colonial clothing. We had a 1937 Home Bureau Quilt on exhibit. This is a feature item in our collection. There are 600 hand embroidered names of residents who participated in it in 1937. There were several one room school houses books there with photographs, children's names, and a variety of memorabilia. There was outdoor farm utensil exhibit, in fact, in one of those newsletters; you might even see a photo of Councilman John looking at some of those utensils. We had photos of some of the earlier hamlets throughout our town whether it is Ushers, Crescent or any of the many hamlets.

Another feature item that was there was a 1718 date stone. This is from an historic house on the Mohawk River front and you are going to hear more about that in another moment. We were in the Fall Festival that year. We had a Spinning Lady that did demonstrations on how to spin yarn and some of our members were teaching children how to make bracelets and potholders. Another really interesting item, we had documented a historic home on the corner of Lape Road & Harris Road. We have photos that include some very old brick ovens and ornate stair railings. This was a cooperative effort between our Planning Board and Historic Society. The Planning Board coordinated our efforts with the property owners. This is one of the things that we like to speak to the board about more in the future. If someone has an old building and for economic reasons they need to demolish it, that is fine, we don't want to prohibit anyone from that, but what we would like to do is to have the opportunity to document that historic building before it is demolished. We can talk more about that at a future day.

2013, we started off with storytelling. Larry Grey, one of our members had a narrative informative story about life on the Erie Canal in 1822. As you listen to Larry you can just imagine yourself on a canal boat going through Crescent in the 1800's. It's a real interesting story.

Alfred Mincher told stories about his time during WWII. This gentleman was at one of the landings at the Normandy beaches. He drove his tank off the landing barge into the water and stormed the beaches which of course were being defended by the German artillery. It is a chilling story to listen to. That was one of our activities.

We had stories from Peter Woodin who grew up in the hamlet in Halfmoon, just down the road from here. He told about his time many years ago.

We had several presentations and exhibits. There was an exhibit here for quite some time on the art of Basket Waving by Master basket weaver Roger Sharp. His work was exhibited out here and it was not just a decorative exhibit; it was also a teaching tool.

The craft of rug painting and rug braiding for homes in the early 1900's was demonstrated by Ellen Kennedy and Beverly Emmerick. It is a craft that is not commonly used today.

Lynda had several presentations. She presented the Mott family story about a family business that started in the northern part of town by Pruyn Hill and Farm to Market Roads. They were farmers that started the Mott Company with the apple orchards on their land. They really went on and made it good from their humble beginnings here in town.

She also presented the story about the Joshua Anthony Baking Powder and Spice Mill right here on Anthony Road. Mr. Anthony was instrumental in bringing the railroad, telegraph and several industries to our town. The story was exhibited here in our lobby and it was also exhibited in the Clifton Park - Halfmoon Library.

A real unique story that Lynda presented, was about the first Town Board Meeting on April 1. 1788. She presented that right here as well as at the Historical building. That story is about a Halfmoon Town Board meeting in a stone house, located on the Mohawk Riverfront. Well guess where the date stone is? The 1718 date stone for the house where that 1788 meeting was held is in our collection. It is right by the front door as you walk in.

Nancy Morris presented a story on Corporal Secor. He was killed in the Battle of Antietam during the Civil War. The exhibit includes photos and artifacts and the Corporal's dog tags. They did not call them dog tags back then. He is buried in the Clifton Park Cemetery. Since her presentation and the word getting out, Nancy has been asked to repeat that presentation at other forums.

We participated in the Halfmoon Town Parade in 2013. We had two floats. Both floats were tractors pulling wagons. We had 12 members that participated in that and each member was dressed in a period costume. In order to prepare the costumes, we had a regular sewing bee over there that went on for several days. We had tables set with two sewing machines going. One of the wagons depicted life on the farm and the other life around the farm home.

If you look at the second from the last page of the 2013 letter, you will see three photos and they are of particular interest. They depict a truly unique collection of ladies formal dresses. These dresses were worn over a 104 year time span, from 1869 to 1973. That is four generations all in the same family. We have 14 dresses in the collection. We have photos and family stories of the people that wore these dresses. This collection is going to be on exhibit at the Clifton Park – Halfmoon Library in September and October. It will take up much display room over there.

These items that I have just listed are some examples, but are highlights that our Society has been involved in. We continue to develop information about how our town was formed and how it developed into what it is today. It doesn't just happen; it is an evolution of changes. It is over 400 years of change since the European settlers started entering this area. All of these events have been captured on digital format, either in still shots or on video. We have them all. In 2012 we purchased a printer. This printer will produce a high quality copy either in color or greyscale for those older black and white photos. It is an excellent copier that allows us to produce quality copies. We acquired a laptop in 2013 with the horns and whistles that were needed to do our work and the software to support it. We expect to purchase a large flat screen TV in 2014, and this will assist us in making public presentations. I told you earlier about Alfred Mincher going off that landing barge on Normandy; just imagine listening and watching him tell that story. This man is well into his 90's. Imagine that on a large screen TV set right up here in the hall. It will send a chill up and down your spine, if you are a student of WWII history.

This all takes money; there is no question about that. Two of the people seated here have paid their dues this year; I will just let that one settle a little bit. We are a 501C3 Non-Profit Organization and we are chartered under the New York State Board of Regents as an Educational Organization. While our members are all volunteer's, we do appreciate the support of our local government. Our Town Board provided many of the tools that we need to perform our work. You provide our experienced Town Historian, Ellen Kennedy with a stipend and a small line item that goes toward defraying the cost of museum supplies. It does not pay for all of them by any means, but it goes in that direction and that is appreciated. You appoint Lynda to be the keeper of records and to be Liaison between your Board and the Society. You provide the facility for us to carry out our work and you support our efforts with your continued show of respect. At our meeting on April 29th, this is not that far away, we will have a feature presentation. You really don't want to miss this folks. One of our senior members, a lifelong town resident is going to tell stories about her time growing up in Halfmoon. Both her maiden family and her married family have been quite involved in the development of this town. Don't miss it. It is really going to worth your time to come and listen to her.

We plan on coming to a future Town Board Meeting and tell you more about where we are going from here. That is all for this evening, so please stay tuned.

Supervisor Tollisen asked if anyone from the public would like the Public Hearing Notice read. Hearing none, the Public Hearing opened the at 7:22 pm.

John Gay, Northeast Consultants for Chuck Hoffman of Oak Brook Commons: Thank you and Good Evening. For many years we have represented Chuck Hoffman and the Hoffman family in the development of Oak Brook Commons and we are very proud of that. It is, I think, one of the premier apartment projects in the Town of Halfmoon and Clifton Park.

Basically what Mr. Hoffman would like to do is, he has found that his office building is too small. It is not working for him anymore and he would like to build a new one. The bad news is, that is in Clifton Park and just in Clifton Park. The parking lot in front of it is in Halfmoon. There are 9 or 10 parking spots in Halfmoon. At the location of his office building, which he has told me he hope to donate to one of the agencies that are building houses for people in need. It would make a two bedroom house, a bit of a squeeze but it would make it. On that site, he would like to build a four unit apartment building. Additionally, a little further south, there is s spot there that is between two roads, and in that location, he would like to build a four unit apartment building and a 7 car garage. It would be 4 garage stalls for the apartment building plus 3 additional ones; he is just a little short there in that area. He finds that most of his renters really like to have a garage.

That is pretty much it on what is going on. We have been in front of the Planning Board in a little more detail. They have given a recommendation to the Town Board and if we succeeded in getting approval from the Town Board, we will be back to the Planning Board for site plan approval.

Supervisor Tollisen: Thank you Sir. Are there any questions from the Board?

Councilman Wasielewski: Yes, just to confirm. A total of eight apartments to be added, no more?

John Gay: That's correct, eight apartments.

Councilman Wasielewski: And the current office would be converted to a residence?

John Gay: No, the current office we are hoping will be secured by some agency and taken from the site and used as house for needy peoples.

Councilman Wasielewski: Where the existing building is used as an office will be removed from the site.

John Gay: That building will be removed from the site and in its place would be the first four unit apartment.

Councilman Wasielewski: I see. OK, thanks for that clarification.

John Gay: You are welcome.

Councilman Hotaling: Is there going to be a new office on the property?

John Gay: The entire site within Halfmoon, there really isn't a spot there. We need a spot where it is convenient for people to get to pay their rent, come in and talk whatever. It would be to the north end of the property. Some of you are familiar with the site, there is a driveway that goes on to Chuck Hoffman's house and it would be just in that area. You will know about it because he purchased this piece of land from you which was part of the well site that he purchased back which was acquired by the town from him. He purchased it back when it was no longer used for a well field and pump station.

Supervisor Tollisen: Any more questions from the Board? Are there any questions from the public?
