The May 7, 2014 Regular meeting was called to order at 2:00 pm by Supervisor Tollisen in the A. James Bold Meeting Room at the New Town Hall with the following members present:

Supervisor Tollisen: Welcome to the meeting of the Halfmoon Town Board. Today is a meeting that we hold every year in the month of May to honor our Senior Citizens! We are so happy that there are so many here and if you hold out long enough there is a cake in the back that I worked on all day, only kidding. The monthly meeting for the month of May, we did a little research and the Town Board has been holding the month of May as Senior Citizen Month since 1979. I asked Lynda Bryan to pull the historical record of it and it goes way back to when John Dudek was Town Supervisor. The check at the time that was presented to the Halfmoon Seniors was \$1,900. We have come a long way since then and special thanks to the seniors. We will get into that in a second.

PLEDGE OF ALLEGIANCE and MOMENT OF SILENCE

PRESENTATION - 2014 budgeted Funds to Senior Citizen Association

Supervisor Tollisen: The month of May is Senior Citizen Month and we do appreciate all of our seniors in our town. I can tell you that the Halfmoon Senior Center is quite energetic. It has a lot of programs and activities and I know that you guys are well over 1,000 members strong. So Congratulations to you and give yourselves a round of applause for that! I know that you have activities that include exercise, that include stamping, I know that because my mother goes to the stamping classes, they include crafts, you have your fall and spring bazaars. You do so much and we want you to know from the Town of Halfmoon, how much we appreciate the Halfmoon Seniors! We appreciate what you do in our community, we appreciate your commitment and support to the town. I will ask the Town Board to come down with the big check and ask the Vice-President and the Board of the Seniors to come on up so we can also make a presentation of this years budgeted funds. I have the real thing and I will give this check to Nancy first.

Clerk Bryan and Councilman Hotaling presented the large check to the seniors as Supervisor Tollisen presented the real check!

Nancy Morris, Vice President of the Halfmoon Senior Citizens Association accepted the check

Nancy Morris: On behalf of the Halfmoon Seniors, I would like to thank the Town Board for this generous check and thank you for everything.

Supervisor Tollisen: In special honor of the seniors as well, we have Liz Callaghan from Senator Marchione's Office. She would like to come up and make a presentation to the seniors.

Liz Callaghan: Thank you Supervisor for giving me the opportunity to speak today on behalf of Senator Marchione, who along with her colleagues in the Senate yesterday passed a resolution proclaiming May 6th Senior Citizens Awareness Day. In the interest of brevity I am not going to read the whole resolution, but I would like to read a couple of lines from it.

"WHERAS, the more than three million residents of New York State, 60 years of age and older, bring a wealth of experience and knowledge to the increasingly active roles they play in today's society. Their past contributions and future participation are a vital part of and an invaluable asset to the fabric of community life and activity.

RESOLVED, that this legislative body paused to urge the residents of New York State to honor all of our Senior Citizens who are the cornerstone of the strength of our nation and to whom a debt of gratitude is owed".

I don't know about other seniors who are present here today, but I for one like being referred to as a cornerstone of our nation. I believe there are many reasons why our senior citizens are important. For one, we are a source of knowledge and together have more knowledge about our lifetime than any computer could ever tell you. I find it necessary to remind my grandchildren of that frequently.

It gives me great pleasure to present on behalf of Senator Marchione, a copy of this resolution to Nancy. Thank you.

Nancy Morris: Again, I would like to thank Senator Marchione for this recognition.

Supervisor Tollisen: Before I move on to the agenda, I just want to give a brief update on the Senior Bus. As you know, about a month or two ago, I did advise that we were in the process of getting a new senior bus. We have gone through the process with the Town Board and what we needed to do to purchase the bus. I can tell you the good news that the bus is ordered. We are very happy about that. With respect to the bus and what I didn't know and I am going to share with you, when they order a bus, they build it from scratch; they don't have any sitting in the yard. So they are actually building our bus and as soon as it is ready, we will let you know. I won't be the first driver of it. So that is the update on the bus. Congratulations again to the seniors and please bear with us with the rest of our agenda.

Now, also when we do our May meetings, I think it has become a tradition that Dr. Robinson, the Superintendent of Shenendehowa Central Schools gives us a short presentation. I will tell you, when I first started as Supervisor, Dr. Robinson and I met, he was one of the first meetings that I had. He certainly does an excellent job at the Shenendehowa Schools. I am proud that he is a colleague of mine and I look forward to working with the Shen schools.

PRESENTATION: Dr. Oliver Robinson, Superintendent of Shenendehowa Central School District

Dr. Oliver Robinson: Thank you very much for the time and Supervisor Tollisen. This is our first formal meeting here at the Town Hall and Congratulations on your new role as well. I will be brief recognizing that you do have a large agenda ahead of you. There are three purposes of being here. We have a school budget vote on May 20th. There are three components to the school vote. One component is the bus purchase resolution. Each year we try to purchase busses as a school district. So part of the resolution is to purchase 10 new busses. We have about 204 busses that pick up about 12,000 students. This gives you some context of how many busses we use. We try to keep the average age of the busses at 8 years old. That is one resolution that is on the ballot.

The second resolution that is on the ballot is three seats of the Board of Education up for re-election. We have four individuals running for three seats. Two of those

individuals are actually here today and I would just like to recognize them. We have Bill Casey & Jim Trainor who are running for re-election on the Board. We have Miss Mary Blaabor who is our Board President. She is not here now, but she is also running for re-election. And we have another gentleman, Scott Johnson who is not here but is the fourth person running for the Board.

The third piece is and probably the most significant piece is the school budget. I will just go by the numbers and I left some flyers here with the information on it. Information is also available on our website and if there are any questions or you need some more information, please contact us and we will get you the answers.

This year's budget, the tax impact is the lowest tax impact in six years. We are looking at a tax impact of the average taxpayer is about 1.3%, based upon what house you have and things of that nature. The budget itself is increased at about 2.15% which over the course of five years, average of about 1.5%. So it is a pretty flat lined budget. For the first time in five years, we are actually looking to add additional staff as a result of the budget. That is the result of, to be quite frank with you, it's an election year here at the state and the state was a little bit more generous with funding and we are trying to maximize those funds to do programs.

Just four major points in terms of where the budget is going. The budget is supported in the direction of a school district. We recognize that our students are going out into a much more competitive world, so therefore we have to prepare them better. There is a lot of focus on innovation which does not necessarily mean technology, buying gadgets, innovation in talking about technology as well as how we change our practice, how we teach to better in line with our kids to learning. If any of you have Grandkids and if you are still lucky to have kids in school, you would know what I am talking about in the sense that kids nowadays learn differently than before. We are trying to make those adjustments as a system to align with that piece of it. So a lot of it focuses on that, but it also focuses on the standards that are much higher for kids now in school, so we have to increase our support for the kids.

The third component is recognizing that the school district demographics are changing. We are seeing more and more families moving into the area, particularly families coming with limited or no English skills. We are looking to address those needs as well. The third big component of it is how do we continue to expand our options and opportunities for kids so when our kids leave Shen, they can in fact be successful beyond the walls of Shen. I just met a nice young lady with a Granddaughter who graduated from Pace University and I am glad that she shared that news with me because I often get the bad news; I never hear the good news. I thank you very much for sharing that with me. That is what we want. We want our kids to be successful after they graduate from Shen. Subsequently, the budget lends itself to that piece of it.

I won't go into a lot of details but just to remind people that May 20th is the budget vote at the Middle School campus. Absentee ballots can be used if you can't make it. You do not necessarily have to be out of town, but if you know that you can't make it to the voting site, you can request an Absentee ballot through my office and we will make sure that you get it.

So this is our Budget and we are pretty excited about this budget because it gives us an opportunity to move forward in a very real sense in terms of some additional programs for our kids. We are excited about the Board election votes; we have three strong incumbents running and a new person running for the Board and excited about transportation and ensuring that we have safe and reliable busses on the road at all times for our kids. So, in a nutshell, that's our budget and again recognizing that the town does have its own business and not take more time than necessary but if here are questions from the Town Board members, I would certainly look to address that or need additional information, I would be happy to provide that or quite frankly come back. I would like to introduce two other people. The mastermind behind the finances at Shen, Mrs. Kathy Wetmore. She is in fact the most powerful person in the school district because she controls the purse strings! Kelly DeFischiani who is our communications person who does all of the communications for the district is here as well. So please let us know if there is more information that you need and we would be happy to do so. If there are any questions, I will address them, but otherwise, thank you for allowing us this opportunity.

Supervisor Tollisen: Anyone from the Board or the public have any questions?

Dora Michaels: How much is the budget?

Dr. Oliver Robinson: You know that is a very good question. Last year I told you that too, and I think that you complimented me! Our budget this year is \$160 million dollars. It sounds like a lot, but if you ever come on the campus and you see all of the things that we do and the number of kids, it actually spreads thin very fast and I am not saying that to validate it, I am saying it as a reality of what we do. It is a pretty big operation that we run at the school system. We have 10,000 kids on campus, another 1,100 kids that go to private parochial schools that we support in some fashion, transportation, text books and otherwise, and then we have probably another 100 kids that are home schooled. So that is a lot of kids that we associate ourselves with directly or indirectly as a school system. Great question, thank you.

Supervisor Tollisen: Dr. Robinson, thank you for coming today. Thank you for update and appreciate the work that you do.

Dr. Robinson: Thank you

Supervisor Tollisen gave a briefing of all of the community events. LifeSong is a not for profit for developmentally disabled individuals. The Town of Halfmoon and the Town of Clifton Park, NY State Police and the Saratoga County Sheriff's Department are co-hosting this event with LifeSong. We are holding the Daffodil Dash at our Halfmoon Town Park. We are calling it a Character Counts event. It is a family event; we want your families to come. There is going to be games for the kids. There is going to be a Bouncy Bounce. The Sheriff's Department and the State Police, we are hoping will have a contest of who runs faster. There is also going to be some canine demonstrations. It is a great event and if any of you guys could come, that would be awesome and please spread the word, it is going to be a great event.

Supervisor Tollisen: Before I get to Reports of Board Members, over the last couple of days, there have been a couple of events in the newspaper that have occurred. I want to talk to you for just a minute as your Town Supervisor about these newspaper articles. For brevity, I have written out my comments so I will read it and it will be in the minutes.

"Recent media coverage, I would like to point out certain aspects of the recent media coverage of your town government. In my opinion, they have been inaccurate and misleading. Ordinarily, I won't mention this; however the public has the absolute right to know when this Town Board conducts business. In this regard, you have my solemn and 100% commitment that at all times in my tenure here, I will follow the law in all respects and without reservation.

In my tenure to date, we have followed the law in all respects. The law requires that public business be conducted in an open meeting. That is what we do here. We have followed the law and will continue to do so. And I will tell you that we have opened up meetings, we have pre-meetings, and we have set up workshops to discuss issues. The law also says that certain things like law suits, contract negotiations, personnel matters and political deliberations may be considered at a private meeting. That makes sense. These meetings are often thought of as being private or sensitive.

The political types of meetings are part of our democratic process and the system by which in New York, we are elected to be Public Officers. Some people are against that system of laws, often well our press may be construed to being opposed to those laws. That is not for me or anyone else to decide. We are not for or against the rules of law here. We simply follow the rules of law. That is to say here in this town, we conduct public business in open public meetings. Political meetings, under the law, are private and understandably so. We, here, the Board members, we see each other in the community, at political functions, at church, restaurants, and we are social and active in our community. It is pretty apparent in these contexts we are not acting in governmental capacity. It is unfair; it is inaccurate and misleading to label those good community and civic interactions as illegal or prohibited by law. It is pretty silly to think that three members of our Town Board cannot be in the same room together or at a party together, or at a church or at a meeting. Section 108 of the Public Officer's Law is clear that any issue with respect to the newspaper article was legal in all respects.

The meeting that was called on Sunday at my house, that did not occur, was not called for by me. It was called for by the Chairman of the political party. I want it to be clear, that I will continue to follow the law and I will continue to work and fight for the residents of this town. But I will not tolerate mischaracterization and misleading comments without going uncommented.

Now with respect to the land sale, a resident came into my office and had some concerns about a land sale that was conducted last year. I was not here when that land sale occurred; I had nothing to do with it. When the land sale documents were provided to me by this resident, had a very legitimate concern, I advised the resident that I would have this reviewed and looked at. That is exactly what I did upon the resident leaving, I handed this matter over to the Town Attorney, Lyn Murphy for investigation and review. I have received her summary and report today and I have reviewed it and distributed it to the board members that are here. We will continue to look at that. I have also met with the Deputy Town Attorney, Mr. Chauvin. I discussed with the Deputy Town Attorney this matter with him and Miss Bryan, Mr. Chauvin has tendered his resignation to the Town of Halfmoon as Deputy Town Attorney, I believe that you have the original. That is effective immediately. With respect to Mr. Chauvin, he tendered this letter of resignation effective immediately stating:

"I believe it is in the best interest of the residents of the Town of Halfmoon, given the recent mischaracterizations put forth in the press regarding the transfer of decommissioned well properties. Although I adamantly deny any intentional wrong doing regarding this matter, I believe my resignation is in the best interest of the Town."

As Town Supervisor, I accept the letter of resignation. Miss Bryan has the original which is supposed to be filed and I believe that the resignation and my acceptance of it is in the best interest of the town. Does anyone from the Board wish to speak before we go into Department Reports?

Councilman Polak: I just want to comment that Mr. Chauvin has been a perfect gentleman and has defended this community to the fullest that he could and he certainly will be missed representing the Board and the community.

Supervisor Tollisen: Thank you, Walt.

Councilwoman Jordan: I'd like to comment. I really feel that this is a very unfortunate, regrettable and actually a horrible event that has taken place. I've been in office for four months now and I was not a Board member when these transactions occurred. Supervisor did ask for a report to be made weeks ago and we've been waiting for it and in the meantime, I think we all have been trying to do due diligence in some fact finding on our own as well. I know that I have.

I do have serious concerns and many questions surrounding the appraisal and sale of the property last year. It appears to be in conflict with Halfmoon's best interest. It's clear that we must insure that conflicts of interest or even the appearance of conflicts of interest don't happen again. So, I still just having been handed this report, still have to look at it and digest it and exercise my due diligence, because I don't think that you want, it's my job to look at facts with due diligence.


Having said that, we will do that and I think that we need to know exactly what happened here, how it happened and we need to find a way to make sure that something like this doesn't happen again. Thanks.

Councilman Hotaling: We have instances that are unfortunate every day. Matt poured his heart out to our town. He worked with us; we thank him for his service and wish him luck moving forward. Thank you.

Supervisor Tollisen: One other item that I have. I did issue a Press Release with some Good News for the Town of Halfmoon with respect to the Town of Halfmoon's Annual Financial Report. I get the pleasure of signing it but my Finance Director does the work.

Supervisor Tollisen read the Press Release and gave the highlights of the Annual Financial Report for the year 2013 end shows a better than expected great news for the Town of Halfmoon. Our General Fund balance which is unreserved or available resources not included in our fiscal 2014 budget increased from \$70,918 to \$844,334. Very good news. Also the Highway Fund deficit of \$536,754, the plan was to eliminate that in a three year period and the good news is that we eliminated it in one year last year. In my press release, I have also cautioned that for 2014, that we can't take the good news for 2013 for granted. My analysis is on a weekly and monthly basis, weekly with my Finance Director and monthly with our Department Managers, is that our actual revenues are below our budgeted and we need to cut where we can. So the town has made cuts already in the budget to take care of the lower than expected mortgage tax that we expected to receive. While we are hoping

that the better weather, the sunshine, maybe some warmth at some point will start to increase house sales and make things better for 2014. I am very cautious and keeping a critical eye on this year's budget. The good news is for 2013, the town ended well so I appreciate the colleagues on the board who worked hard and I appreciate our Department Managers and I appreciate our employees who work every day so diligently for us. Thank you for that.

"Annual Financial Report for 2013 shows increase in Fund Balance and FHALEMOON TAN. TOWN CLERK Elimination of Highway Deficit"

Halfmoon Town Supervisor, Kevin Tollisen, announced today that the Annual Financial Report for the Town of Halfmoon for fiscal year 2013 has been submitted to the New York State Comptroller. Supervisor Tollisen stated the Town ended the year 2013 in better financial shape than in 2012. The General Fund, fund balance, which are unreserved or available resources that are not included in the fiscal year 2014 budget, increased from \$70,918 to \$844,334 and the highway fund balance deficit of \$536,754 was completely eliminated. Supervisor Tollisen said the increase in fund balance was a direct result of the coordinated effort of the Town Board leadership in imposing a spending freeze on non-essential spending, the staff of the Town who made every effort to cut spending, and better than expected revenues. Tollisen said that "this is great news for the residents of the Town of Halfmoon as Halfmoon's General Fund fiscal reserves are now growing once again".

Tollisen cautioned, however, that the Town of Halfmoon's current 2014 budget is already in a spending freeze as the Town is carefully monitoring budgeted versus actual revenues received. Tollisen stated that for the first few months of this year, revenues are lower than expected, thereby imposing the spending freeze on non-essential and discretionary budget items. The Town has made aggressive efforts to reduce portions of the 2014 budget with changing health insurance premium plans and removing certain equipment purchases from the general fund. Tollisen affirmed that there is no reduction in the services provided to Halfmoon residents; in fact, the services are continuing to improve.

Town Board Member Daphne Jordan said that she believes that "the Town is moving forward in a positive direction" and reiterated "the Town will continue to look for ways to cut spending, thereby saving monies for the residents of the Town of Halfmoon".

Highway Superintendent John Pingelski was also pleased with the news. Superintendent Pingelski advised that his Department worked incredibly hard to reduce their Department's operating costs, thereby allowing the Department to save money. That coupled with additional revenues helped to eliminate the highway deficit in one year, not in the three years as anticipated.
