The August 1, 2006 regular meeting of the Town Board of the town of Halfmoon was called to order at 7:00 pm by Supervisor DeCerce at the Town Hall on Harris Road with the following members present:

Also present: Frank Tironi, Director of Water; Laurie Sullivan, Deputy Town Clerk

The Town Board Workshop was held in the Board Room at 6:15 pm; no action was taken. The Supervisor led the Pledge of Allegiance.

Councilwoman Parker offered a moment of silence for the recent passing of Joseph DeCerce, Supervisor DeCerce's father who was also a former Town employee.

Supervisor DeCerce stated he appreciates everything that everyone did during this time.

The Supervisor welcomed the Clowns present who are being honored in observance of "International Clown Week" which is August 1<sup>st</sup> through 7<sup>th</sup>. He invited them to come to the front and he read the following proclamation:

### REPORTS OF BOARD MEMBERS AND TOWN ATTORNEY

Councilwoman Wormuth reported that the recreation program is finishing up a wonderful six weeks of summer. She stated she and, the Supervisor have been to all three sites and the kids are having a wonderful time. She stated the youth they employed and the permanent recreation staff are doing a magnificent job and she wants to thank them.

Supervisor DeCerce stated he can attest to lots of good things happening and the kids are having a really good time and it's balanced and safe and, is a credit to this Board, Mrs. Wormuth and the staff who are working very hard.

Councilwoman Parker reported that tomorrow night is the last concert in the park from 7 to 9 pm in the gazebo.

Councilman Bold asked Frank Tironi if residents have started to hook up to the water on Route 236 and Woodin Road.

The Director of Water, stated some have started but not too many as of yet because they are having difficulty hiring contractors.

Councilman Bold reported that the historic signs, one near Stewarts at the Crescent Bridge and the one at Exit 8, have had some attention by the Parks crew who did the design work and construction and have been working on the landscaping, putting in pavers and potted plants. He stated they are close to being done and it certainly looks nice.

Supervisor DeCerce stated they have done a nice job with it and he credits them for taking on this responsibility. He stated they might want to consider street lights at these locations because it is so dark at these sites.

Councilman Polak stated has started doing some work on the lights and will continue working on the possibility of obtaining them.

Councilwoman Wormuth commented on the beautiful landscaping work and the courtyard in Town Hall. She stated the Town maintenance crew have done an absolutely phenomal job making the area beautiful at very little expense but a lot of hours of hard, hard work but it is such a beautiful. She stated it was a combination of the maintenance crew and buildings and grounds.

Supervisor DeCerce stated the key was Harold Robbins to come on staff and its been amazing. He stated the ships are wonderful as is the water fountain.

The Supervisor reported on some problems at Colonial Green and read the following letter submitted by the Highway Superintendent, Lee Buck:

## Lee buck letter

He stated he has had contact with Larry Grey and ten different neighbors are suggesting they do something. He stated the water comes in two different directions and the storm sewers can't handle it because they are very old and the catch basins are not what we use today and the culverts are small.

Councilman Polak stated Mr. Grey has the lowest property and gets the back up water from the catch basins off Woodin Road and also all of his neighbors water and comes from every direction.

Supervisor DeCerce stated it seems as they should engage Clough Harbour to do a proposal for a field survey, feasibility engineering and a budgetary cost estimate.

Councilman Bold stated it is a great idea to get a proposal to do field survey work and budgetary estimate.

Councilman Polak stated this has been on- going and Mike Bianchino has been over there and it is a major undertaking of man holes and distribution system and down stream improvement. He stated to move the type of water that is coming in there we have to make improvements and upgrades to downstream to handle the water.

Councilwoman Parker stated they have had discussion with Clifton Park and it floods in Clifton Park's ditches.

Discussion followed regarding the Town boundary line.

Public privilege for discussion of agenda topics was opened by Supervisor DeCerce; no one had questions or comments.

Supervisor DeCerce stated about three years ago we got burned by individuals who elected not to pay their bills quarterly and it took a while to actually rectify that and it doesn't make sense not to stay up to par.
