PUBLIC COMMENT (for discussion of agenda topics)

Joe Christopher, Werner Road: Actually, I would like to comment on something that was on the last agenda. Mr. Tollisen, you promised the residents of Halfmoon a new direction. You promised increased accountability and transparency. And I know that many people in this town, I know that there are many people in this town that believe that you can provide that. This is a republican town and I am in awe of the resolve of the residents who believe you guys can straighten all this out. The appointment of a Councilperson to fill Craig Hayner's vacated seat was an opportunity to show that you are serious about your promises. You said that there would be an open and fair process to fill this position. Yet, you decided to appoint the Legislative Director for Kathleen Marchione and the pick of the Town's GOP Committee. And I am not here to advocate for any one candidate. You interviewed seven qualified people. I believe that this appointment was the most blatant disregard for the vision and direction that you promised the residents of Halfmoon and supports the corruption and cronyism we, unfortunately have become famous for. Supervisor Tollisen: Mr. Christopher, if you would like to stay right up there, I can respond to that. First of all, just so everyone's clear, this was a vote of the entire Town Board for one. Number two; there were seven qualified candidates. Mr. Polak and I interviewed them first and then Mr. Wasielewski and Mr. Hotaling interviewed them second. All four board members interviewed all of the candidates. Like I said publically in the newspaper and I will say it again, all seven individuals had great qualifications. The decision was made as a result of the four board members. This was an open process. This was, in despite a few people's comments, this wasn't a political event

Joe Christopher: So it was just

Supervisor Tollisen: Let me finish and then I will let you talk. Miss Jordan's qualifications, for myself, why I voted the way I voted, was based upon, number one, she has served on the Zoning Board of Appeals, which is a town government position. Number two, she served on the Library Board of Trustee's. She was the Treasurer who oversaw a 3 million dollar budget and a construction budget of ten million dollars. Additionally, she served on the YMCA, as a swim official, she has a record of community involvement and that's why myself why I choose her. OK. We have turned the page of the corruption. We have turned the page of all of these items that have whatever given the town a black eye or whatever you may consider

it. OK. This decision is made and obviously Miss Jordan, she will have to show to the people her resolve as well. But that is the decision I made.

Joe Christopher: I truly hope it was a good one.

Supervisor Tollisen: I appreciate your comments, but I just wanted you to know just exactly the reason why I made the decision I made. OK?

Joe Christopher: It was just strictly coincidental that your process and the process of the Halfmoon Republican Committee gleaned the same candidate?
