The October 17, 2006 regular meeting of the Town Board of the Town of Halfmoon was called to order by Supervisor DeCerce at 7:00 pm at the Town Hall on Harris Road with the following members present:

The Town Board Workshop was held in the Board Room at 6:15 pm; no action was taken. The Supervisor led the Pledge of Allegiance.

#### REPORTS OF BOARD MEMBERS AND TOWN ATTORNEY

Councilman Bold reported that the work along the Canal Towpath is about two-thirds completed and will be finished in just a few days. He reported on the Town Hall project stating there are often concrete trucks and they are working on the forms for the footings. He stated there are two well drillers on site and they are drilling some very deep holes.

Councilwoman Parker reported she would like to add a resolution for the fire fighters because this is Fire Prevention Week and they do a wonderful job for us.

She stated the last rabies clinic for this year is tomorrow evening at the animal shelter.

She stated she wants to commend Eric Hamilton and Henrietta O'Grady for the fine job they did on the Duathlon, which she attended and Supervisor DeCerce was the starter. She stated she was impressed by the dedication of the group of people who organized as well as all the runners and their families. She stated she heard the winning time was about one hour and nine minutes. She stated kudos to Krause's and Halfmoon for sponsoring the site again and also the Town highway department employees.

Supervisor DeCerce stated Eric Hamilton with the Mohawk Towpath Byway Coalition and Henrietta O'Grady really started this event and its grown annually; this year there were over 80 runners and bikers.

Councilman Polak reported on the Fall Clean Up and thanked the highway and transfer station employees for all their work. He stated the Town took in 20 tons of metal and received \$1,222. He stated the total cost to the Town for the clean up was \$13,499 and we received in metals, cardboard and paper, \$1, 276 and the total cost to the Town was \$12,222.

WHEREAS, these individuals have trained on their own time and learned to deal with firematic functions and emergency issues with exactitude and efficiency; and

WHEREAS, the dedication and bravery exemplified by these individuals is that which we seek to promote and to use as examples for our youth; and

WHEREAS, the firefighters and ambulance personnel are called out at all hours of the day and give of their time and, taking from their family time without complaint and, perform their tasks with unyielding consistency; and

WHEREAS, the risks and attendant dangers in their services are evident by the tragedy of all of those firefighters and paramedics who were lost responding to the terrorist attacks on the Twin Towers; and

WHEREAS, the general public has become accustomed to the tremendous care and treatment of these dedicated professionals; and they have come to expect and to accept their services without fully appreciating or understanding the risk and the danger these individuals place upon themselves every day; and

WHEREAS, the Town Board of the Town of Halfmoon and the people of the Town of Halfmoon wish to acknowledge and to commend these brave individuals for their unwavering dedication to the public and to the preservation of the public's health, safety, and welfare, and

WHEREAS, the Town Board of the Town of Halfmoon wishes to acknowledge all activities and firematic functions from the simplest crowd control and traffic control at fire scenes to those that enter burning buildings and perform CPR on critically ill patients; and

WHEREAS, they epitomize those ideals of self sacrifice and public service which only few strive to obtain; and

WHEREAS, the Town of Halfmoon acknowledges these individuals as the "Home Town Heroes" of our community.

Supervisor DeCerce reported that Saratoga County Clerk, Kathy Marchione, received a resolution of congratulations from the County Board of Supervisors which congratulates Kathy and the County Clerk's employees on the award of the William H. Kelly Annual Archives Award for excellence in local government archival program development. He stated this award was offered without anyone asking for an award and she does a really good job. He stated her office went through all the volunteer firemen exemption certificates and one had connection with the present Board of Supervisors and it states that his Uncle Vic was given the exemption certificate in 1955 and was a member of the Clifton Park Volunteer Fire Department Inc., Clifton Park, Halfmoon.

Supervisor DeCerce reported that two years ago there was a piece of property that came up on the tax auction in Colonial Green on Bayberry Drive, across from the former water shed. He

stated at the time we were concerned about the drainage because it looks like a piece of property someone would be excited about until they buy it and then realize they can't do anything with it because a drain runs through the middle. He stated the Town sent our Assessor to the auction with the intention of purchasing it. He stated Mr. Deets is the person who won the auction purchase and he decided to ask the Town if we wanted to purchase the property. The Supervisor stated it would cost the Town \$1000 to purchase and is just about the amount it will cost him to acquire it. He stated Mr. Deets offered \$650 and there are fees in the amount of \$984 attached and the Town could buy it from him for \$1000. The Supervisor asked the Board for a resolution to purchase this property from him and he will have it deeded over to the Town of Halfmoon.

Councilwoman Parker stated it is a piece of property we intended to purchase before and we will have a good use for it to expand drainage and is something we definitely want to pick up.

Supervisor DeCerce stated the Highway Superintendent is also in the same thought process.

Attorney Murphy stated he came to update us regarding prevailing wage and our responsibility and if we are in compliance. She stated he is new to the area and just wanted to touch bases in case we had any questions or concerns and is just doing a proactive visit.

Councilman Bold stated it is extremely difficult for small companies for small bids and it is difficult to get anybody to bid on them.

Attorney Murphy stated our responsibility is just to notify them what the prevailing wage rates are and hand out a sheet in accordance with the statute, per the Towns responsibility.

Supervisor DeCerce stated he feels the complaints are accurate but we have to follow all the steps. He stated if the business owner is the only person working on a particular project.

Councilman Polak if there are employees it is required to have the prevailing wage documents and they must be on site in their project office so if the Department of Labor comes on the site they will look for the documents.

WHEREAS, to facilitate the most efficient and effective incident management it is critical that federal, state, local, and tribal organizations utilize standardized terminology, standardized organizational structures, uniform personnel qualification standards, uniform standards for planning, training, and exercising, comprehensive resource management, and designated incident facilities during emergencies or disasters; and

WHEREAS, the NIMS standardization procedures for managing personnel, communications, facilities and resources will improve the state's ability to utilize federal funding to enhance local and state agency readiness, maintain first responder safety, and streamline incident management processes; and

WHEREAS, the Incident Command System components of NIMS are already an integral part of various incident management activities throughout the state, including all public safety and emergency response organizations training programs; and

WHEREAS, the National Commission on Terrorist Attacks (9-11 Commission) recommended adoption of a standardized Incident Command System; now, therefore, be it

RESOLVED, that the Town Board of the Town of Halfmoon hereby mandates the National Incident Management System be utilized for all incident management in the Town of Halfmoon, effectively immediately.
