Next, we are going to have a public hearing amending the Local Law as it relates to demolition. Madam Clerk would you please read the Public Hearing Notice?

# PUBLIC HEARING: AMENDING THE LOCAL LAW AS IT RELATES TO ZONING ON DEMOLITION

No person, firm, corporation, association or partnership shall commence the demolition of any building or structure or any portion thereof without first having obtained a permit from the Code Enforcement Officer. If the building or structure proposed to be demolished has been in existence for more than seventy-five (75) years, a twenty-one (21) day time period shall commence during which demolition shall not occur unless necessary to protect the health, safety and wellbeing of the surrounding area. When an application for demolition described herein is received by Code Enforcement, Code Enforcement shall immediately contact the Halfmoon Historical Society and advise them of the application for demolition. To the extent practicable and with written consent of the owner, the Halfmoon Historical Society shall work with the owner to document the historical nature of the buildings and structure as well as preserve the contents.

In the event that the Historical Society has completed their documentation prior to the 21 days, rather than hold up the demolition permit, it would allow for a shorter

time period upon written authorization by the Historical Society that they are finished with that project.

# **Supervisor Tollisen: The Public Hearing will be opened at 7:08** Does anyone from the Board have any questions? Are there any questions from the public?

Jim Bold, President of the Halfmoon Historical Society: I won't even try to top that last presentation. I just wanted to briefly present my thoughts relative to this proposed change in the ordinance. The intent of this is to preserve and document these historic structures through photography and to gather the story. We would like to be able to go in and take photographs, and perhaps some measurements. If we do observe any of the interior items such as a wall hanging, a particular piece of furniture that could be interesting, we would at least request the owner to make a donation. If they choose not to donate it, that is their prerogative and we have no control over that. But, we would at least identify it.

We had the opportunity to be at Smith's Restaurant in Cohoes recently, and on the back of the menu they have a whole story about that building, the history and the people. What a fascinating story it is to read. For those of us that are interested and not everyone is, but for those who are, you learn from it. Last night we were at the Power's Pub, same thing. They have a very nice story on the back of the menu. Ellen helped provide some of the information for that story. When you read that you get a real sense of the place. The idea is to gather the story of these older structures and I hope that the Board will support this. Thank you.

Pete Bardunias, President and CEO of the Southern Saratoga County Chamber of Commerce: Hi everybody. Thank you for the opportunity as always to participate in these hearings. The Chamber Board does not have any official position on this one way or the other, but I did want to say thank you to Jim for presenting last night to our Historic Business Preservation Task Force. We really appreciated that. He alluded to the meeting at Power's Pub; it was really great to do that, it was really very helpful. It is a very well-meaning plan to try to help preserve some of that wonderful history that we have here in the Town of Halfmoon. I think it would be great to save whatever we can and if business owners are obliging, that is so much the better.

One thing I just wanted to add is that looking ahead; it might be worthwhile to have on the radar screen, that there are other business owners who are trying to preserve some of those historic buildings for their own use as businesses. It is one thing to talk about those that maybe can no longer be used, but there are others like Power's Pub that we hope will last in service for a long time. Our task force is kind of in the middle of fact finding so I am not ready to give any results yet, but one thing we are finding is that it does appear that the people who do try to do that, run into some undo hardships. It's a lot easier to tear down the old building and put up a straight rectangular structure. That is not what we want to do when possible. We will be having some recommendations as per our charter from the Board of Supervisor's on the committee of development program. We are going to put out some recommendations to try to help business owners who are trying to preserve historic buildings and they don't have to be officially historic. We want to make sure that we do our best to help them as well. That is all that I have, thank you.

Superisor Tollisen: Thanks very much.

**Tom Mithen:** I am a resident for two years in the Town of Halfmoon. I was very pleased to receive this amendment and I think that it means a lot to know that those of us who are also over the 75 year age, I glad to see that they are also

concerned about buildings. I commend you for it. The only question that I have is toward the end where it says "with the written consent of the owner", the question that I have, suppose the owner does not want to give consent, what do you do then?

Attorney Murphy: The town is not in the position to force a private entity to allow another private entity into their building. So, we couldn't force someone to allow the Historical Society to come in. We would encourage it as much as we can, but unfortunately we are not legally able to force

Tom Mithen: It is voluntary on the part of the owner then

Attorney Murphy: Correct, it will be encouraged

**Tom Mithen:** Let's suppose the owner decides it is a good idea to document as Jim indicated the historical value of the building or just even understand if there is any historical aspect to the building, who really takes the lead in that? Is it the Historical Society or is it the owner?

**Attorney Murphy:** Once the owner gives consent to the building department, the building department would reach out to the Historical Society and they would work with the owner.

**Supervisor Tollisen:** Thank you. I will say that this resolution was introduced to us by the Historical Society, so thank you for bringing it to our attention.

There is one slight change to the way it is written on the agenda. It is not a material change but it is a change that with the 21 day waiting period, in the event that the Historical Society can wrap it up prior to the 21 days, rather than hold up the demolition permit, it would allow for a shorter time period upon written authorization by the Historical Society that they are finished with that project. OK? That would be the only change.

Anything further? In order to proceed we would need to have a resolution for a negative declaration for SEQRE

#### **REPORTS OF BOARD MEMBERS AND TOWN ATTORNEY**

**Daphne Jordan:** 1) Chair of Business and Economic Development, Chair of Insurance (Liability and Medical), 2) Liaison to Open Space and Trails Committee, (3) Co- Liaison to Zoning Board

Business and Economic Development Committee had a group tour of potential and existing commercial and manufacturing sites in Halfmoon last Saturday. It was led by SEDC President Dennis Brobson. It was very informative as we were able to see and hear what businesses are touring Halfmoon and what they have to say about the available sites. Halfmoon is a very desirable location. There are pockets of zoning that the committee feels must be changed for businesses and areas that are zoned for businesses that aren't necessarily the best for businesses. They might be better used for residential or open space. At this point the Business and Economic Development Committee would like to meet with the Zoning Review Committee at some point in the near future to hear what we have to say and see what Zoning Review has to say about it.

**Open Space and Trails Committee:** They had their last meeting for the year Monday evening. We went over the Trail projects and Grants update for everything going on. Among those that we spoke about were the Swatling Falls, the McDonald's Creek Project, the Champlain Canal Extension South, Erie Canal Community Connector, Lighthouse Park, Champlain Trail Connector, and the Safe Route to School, Falcon Trace Trail and the Champlain Trail Sign Project. So the committee has been very busy this year.

Jim Bold also gave a presentation on Open Space and we looked at preservation tools that have been provided by Saratoga PLAN. It is the committee's intention next year to work very hard on developing an informative pamphlet for the community on Open Space and working toward the goal of more open space in Halfmoon. That is all that I have.

**Supervisor Tollisen:** This is a joint request by the Towns of Clifton Park and Halfmoon for DOT to address some of the traffic congestion on the Clifton Park side with Kinns Road and the Halfmoon Side with Farm to Market Road and the intersection with Route 9. It is interesting, I read the letter a couple of times and it basically says that they agree with our analysis, that we need turn lanes and or turn signals, but there is no funding available, so you are kind of stuck with it. I am not happy with the results and neither is the Town of Clifton Park Supervisor. We are stuck with it for now and will continue to badger them in the future.

# OLD BUSINESS

**1. Resolution** to ratify the resolution that was tabled from November 5, 2014 to amend the sale of the Poplar Drive parcels to include the paper street, now that the new appraisal is completed.

**Supervisor Tollisen:** Just let me give you information on what we are doing here. We had authorized the sale of Poplar Drive. There was a contract for the sale of Poplar Drive with a town resident. There was some question whether or not the paper street that is part of that land was included in the sale. We asked the appraiser to go back and relook at it with the paper street. So Bryce appraisers did come back and Ms. Drobny looked at it again when the appraisal came back. Ms. Drobny, what was the change in the appraisal?

#### Deputy Attorney Drobny: Less than \$1,000

**Supervisor Tollisen:** Just under \$1,000 extra dollars. The original appraisal was for \$54,405. The appraisal with the paper street is \$55,365.
