**Supervisor Tollisen:** Our first presentation this evening is for an Eagle Scout. I remembered down at the Senior Center, Eileen asked me if we had a spot where the seniors can come out and play bocce ball? There is a flat spot out behind the Historical Society. I thought that this would be a good project for Nick and for a perfect cause. We talked and went over a few designs, and looked at a neighboring facility in Mechanicville. On the day of construction, Nick had more people than I have ever seen at any of the Eagle Scout projects that have been done here. There was a huge crowd, very efficient, and streamlined the whole project. They started early in the morning, we helped excavate and get some stone dust in there, but all the rest of the hand work, finishing grade and everything else was done by them. It is a great thing. **Supervisor Tollisen:** Next, we will have a presentation regarding the Crescent Gardens Mobile Home Park application.

**Attorney Murphy:** Mr. Supervisor, as the Board is aware, the applicant in this matter is my brother. Although, I do not have any monetary interest, but to avoid any looks of impropriety, I will be recusing myself from this matter.

**Supervisor Tollisen:** OK, thank you.

### PRESENTATION: CRESCENT GARDENS MOBILE HOME PARK

Gavin Vuillaume, Environmental Design Partnership on behalf of MRK Real Property, LLC and Michael Klimkewicz

Gavin Vuillaume: Good evening. First off, I would like to thank the Town Board for giving us this opportunity to make this presentation for what we hope will be a very good project, not only for the applicant but also for the town. This is the Crescent Mobile Home Park, and most of you are probably familiar with it. It is located just off Plank Road right behind Rome Plaza now known as Crescent Commons with Fred the Butcher. The property itself started out in the 1960's, 1970's as a mobile home park set on several broken parcels. Currently, I believe that there are 19 mobile home units on the parcel and Mr. Klimiewicz along with that purchased some additional properties to hopefully expand and improve the mobile home park itself. That is really the focus for our proposal is to request, actually it is the Town Clerk that issues the permit for the mobile home park and any changes to it to what I think is section 107 of the zoning code that allows for that. So we have been in

front of the Planning Board and Town Board. We have already been in front of the Planning Board a couple of times and have received many recommendations from them and the reviewing engineer Clough Harbour. We have also spoken to the water department and sewer district regarding providing utilities to the project. We have been involved and actively pursuing an application for probably a couple of months now. We are excited to be able to present this to the Town Board and answer any questions that you have.

As far as the details, I will quickly go through some of the improvements and then Mr. Klimkewicz will say a few words about his goal for this project. The existing project right now, I think are on about a three acre parcels and they are kind of packed in there. Mr. Klimkewicz bought some additional property outside of that to bring it all together in one cohesive plan. Right now, I think with the additional acreage we are looking at 5.19 acres of continuous property where we would essentially keep maybe 5 or 6 of the existing mobile homes that are in a good location and essentially remove or relocate the remaining mobile home units. We obviously would be adding some additional units to the project that are well within the density requirements for the mobile home park. I believe the density is typically 6 units per acre and we are just at 5.9 units per acre. Again, adding additional units to be able to afford to make some of the improvements that we feel would be an actual benefit to not only the surrounding area but to the park itself. There is an existing road there now, but we would bring in a new road, we would expand the sanitary sewer and expand that into areas that presently are septic systems and incorporating new sewer service not only to the new mobile homes but to the existing ones. We've also talked to the town about making some drainage improvements on the site. The drainage is pretty good there but there is always room for improvement and certainly that may be an asset to the surrounding area. We are also looking to expand the roadways. They are very narrow and tight. There are a lot of large trees in the way. It is a very crowded space right now and we would like to improve on this visibility and its function.

That is really most of the improvements from the site engineer's standpoint. Michael Klimkewicz would like to say a few words about the project.

**Supervisor Tollisen:** Could you just summarize how many units you have existing and how many units you are proposing?

**Gavin Vuillaume:** There is existing 19, so we are going to add 12 units for a total of 31

Michael Klimkewicz: We actually removed one unit already. I am Michael Klimiewicz, the owner of this property and also the adjacent plaza. What I would like to do and the ultimate goal, is to make low cost affordable housing for seniors. We would like to take this park, open it to seniors and market it to seniors and give them a place where they can go for \$400.00 a month. We are lucky because where else can you find something like that and improved quality facilities in every corner of the lot? The roadway is going to be larger and it's going to be black topped; now it is mostly gravel. The roadway is going to be wider with better access for emergency vehicles. The larger trees are all going to be removed and again for better access for emergency issues. We are going to have a recreational park off to the side and a walkway to the Crescent Commons. Essentially the people will be able to walk over to the plaza and do some grocery shopping, or get a haircut at the beauty salon. I asked Michelle to come along from Retail of Saratoga. Michelle was recently recognized by the Senator and a number of distinguished folks as the Most Distinguished Woman in the Capital District in 2014, and she is going to help some of the seniors that are there now to transition.

Michelle Larkin, from Retail of Saratoga. We are a local non-profit organization that partners with the community and adheres to offer home repairs at no cost to

the homeowners. We are asked to work with new and possibly help some current homeowners that are in the park. We look forward to working with the homeowners and help them.

**Michael Klimkewicz:** Thank you Michelle. We are trying to help the people that are there now, but the end result is going to be a new park, new roadways with better access.

**Supervisor Tollisen:** Any questions from the Board?

**Councilman Connors:** Supervisor, I do. Mr. Klimiewicz, I know that the Fire Chief had some concerns in regards to turning radius's for their fire apparatus. Has that been addressed?

Michael Klimkewicz: Yes

**Gavin Vuillaume:** Yes, I actually met with the Fire Chief and there are some areas that needed to be improved and I assured him that they would be addressed.

Councilman Connors: OK

**Councilman Hotaling:** You were going to go with public sewer and water correct and the road is it going to be a Homeowner's Association type or is it going to be a public road?

Gavin Vuillaume: Private

**Councilman Hotaling:** Private road, so who is going to take care of snow plowing and all of that?

Gavin Vuillaume: We will.

Councilman Hotaling: OK, thank you.

**Councilman Wasielewski:** During the Planning Board meetings, there were some concerns expressed by some of the neighbors about residents cutting through onto their private properties. Have you met with those homeowners and addressed their concerns?

**Michael Klimkewicz:** Yes, I met with Susan Sheridan. She was the one who expressed the concern and along with her son next door. We have committed to them to build a fence. We are going to put up a fence on that section and satisfy their concerns.

**Councilman Connors:** Is that coming off their property line, is that the plan?

**Michael Klimkewicz:** It is. It is going to be on her side of the property.

**Supervisor Tollisen:** The resident that did have concerns, was in Town Hall today and she did speak with me and our Director of Planning and she advised us that the issue was resolved. I do not have any other ones at this time.

The next step, although it is not required but I believe it is recommended to us to set a public hearing

Kevin J. Tollisen (Town Supervisor) I do have one more resolution to add to the agenda that came to my attention this afternoon. The Town of Halfmoon is currently working on a joint project with the Town of Clifton Park for what we call the Erie Canal Community Connector Trail. In conjunction with that trail, we have two grants. One is with the Town of Clifton Park and one is on our own. The Halfmoon portion of that grant which is a \$200,000 grant, but it is a 50/50 match. So, we need to match that \$200,000. Some of the monies can be through services, but the rest of it will be through Recreation Funds. I know that the Board is aware of this, but I would be looking for a resolution tonight to authorize the use of \$200,000 of Recreation Fund money as matching funds for the Erie Canal Community Connector Trail and that amount would not exceed \$200,000 and to authorize me to execute the contract with the Department of State per the review and approval of the Town Attorney.

I apologize for the short notice of this but this was given to me today and we do need to proceed forward. If we are going to move forward, unfortunately, these grants come and go but we want to make sure that we save that and move forward for the purpose of finalizing that trail and do construction in the spring of next year.

# **PUBLIC COMMENT (for discussion of non-agenda items)**

Larry Koniowka, 15 New Castle Drive: I haven't been able to make the meetings lately but I always look at the minutes. At the last meeting you had something on about the demolition. I was just curious, was that just buildings or was that sheds that was supposed to get approval. I know that we have a couple of sheds on our family land and my brothers are thinking about them.

**Attorney Murphy:** I believe that it is structures in general and the purpose of it is because in many older structures thee is asbestos, so they have to make sure that there isn't danger in the demolition of the structure but I can look it up while we are here and give you an answer before you're done.

Larry Koniowka: OK

Councilman Wasielewski: Are you talking about the historical

Attorney Murphy: Yes, he is just asking in general

Larry Koniowka: In general if you are going to take down an old shed, do you need to get permission to do so? I know that you need to get permits to build a new shed, depending on the size, but to take it down

**Supervisor Tollisen:** What I will do is to have the Code Enforcement Director call you tomorrow. Just give me your phone number and I will have him call you and you can address your specific concern.

**Larry Koniowka:** OK. Also on the last agenda there is something about Linden Village and I was just wondering if you can just clarify for some of the people here about what that was all about. I might have talked to you and you explained about it being historical. Would that be this or something else?

**Councilman Wasielewski:** There have been a lot of conversations about Linden Village, obviously. Do you mean the archeological, has that happened?

**Larry Koniowka:** I don't know. There is something on here about receiving something from the State Department

**Clerk Bryan:** Oh, that was the filing of the Local Law. The State notifies us when they file our laws at the State level.

**Supervisor Tollisen:** It has to be filed with the Department of State and that was the notification that it was filed.

**Larry Koniowka:** But there is still going to be an archeological study looked into right?

**Supervisor Tollisen:** All of the requirements that are contained in the PDD legislation have to be met.

Councilman Wasielewski: That's required.

**Larry Koniowka:** I was curious and something that I really wasn't sure of, when new developments are proposed and roadways are created in the developments, who actually design the roadways? Is it the builder themselves or do they work with the Planning Department to create the roadways. Sometimes, I have noticed in the past that they went through somebody's yard. Linden Village with the Craver's and Princeton Heights between two people's yards. I was just curious as to who actually creates these roadways in the developments; the Planning Board or the developers themselves? Does anyone know?

**Supervisor Tollisen:** Just to give a generic answer, which is the best I could give. When an application comes in, an application would include proposed roads and from that point it gets reviewed by the town engineer, by the Highway Superintendent and all of the applicable parties. While the builder may propose the road, it does get reviewed by our professional staff to go forward.

Larry Koniowka: Alright, thank you.

John Pingelski, Highway Superintendent: Just a little more on that too, Princeton Heights on Princeton Drive, that is not people's yard.

**Larry Koniowka:** I know that.

**John Pingelski:** It is not their yard. They intentionally left pieces of property open for roads. So it is not like people's property is being taken away. It is not actually their yards, it is intentionally left open.

Larry Koniowka: Correct. I know that it is not their yards, but the roadway goes right between two yards where they could have gone two houses up where it would not have been between anyone's houses. It wouldn't disrupt their lifestyle. It is more these people lifestyle that is being disrupted by a new development that I am concerned about rather than who owns the property. Is right for a road to go between two people's where one has a pool on one side and the other one has a

swing set on the other side. While you could have gone just two houses up and there is no pools or houses. For me, I am not a developer, I am just a cook.

John Pingelski: (said something from the audience but could not be heard)

**Larry Koniowka**: At the public hearing and meetings, but it fell upon deaf ears of the logic behind going between two people's yards and disrupting their lifestyle just so a developer can get a development in there. The logic behind it was not there for me and that is why I keep

**John Pingelski:** People knew that this opening was there for a future road. The road was actually put there before the houses.

**Larry Koniowka**: It's not a road, it is just open space. You could have just put a trail there, you could put a statue there of the developer you know. I am just saying that the logic behind going in between two people's houses even though it is not their property, maybe give them a chance to buy a bit of that land so that they could close it in and they could still build their development. You are just not disrupting people's lifestyle. So, that is my concern.

**John Pingelski:** The people knew that when they bought the property.

Larry Koniowka: The developer knew that he could create any type of road style that he wanted without disrupting the lifestyle of people. That is all that I am saying.

Supervisor Tollisen: OK, thank you.

There being no further business to discuss or resolve, on a motion by Councilman Hotaling and seconded by Councilman Connors, the meeting was adjourned at 7:50 pm.
