The only item that I have on the agenda for this evening, which I have asked the Board to move forward is, we need a resolution authorizing the Town of Halfmoon to enter into an agreement with Lakes to Locks Passage, Inc. for the completion of Wayside Signage. That is grant monies that we need to move on in order to obtain those funds.

WHEREAS, the Town of Halfmoon has a grant from the Historic Hudson-Hoosic Rivers Partnership, administered through the Natural Heritage Trust, for the completion of wayside exhibit signage along the Champlain Canalway Trail;

WHEREAS, Lakes to Locks Passage, Inc., is a 501c3, not-for-profit corporation with the mission to further the appreciation, recognition, stewardship and revitalization of the natural, cultural, recreational and historic assets of the communities along the interconnected waterway of the upper Hudson River, Champlain Canal, Lake George, Lake Champlain, Chambly Canal and Richelieu River;

WHEREAS, Lakes to Locks Passage strives to unify the region's historic, cultural, natural and recreational resources to establish a world-class destination for national and

international travelers by utilizing the Lakes to Locks Passage Design Standards to create a seamless interpretation program.

NOW, THEREFORE, BE IT RESOLVED, that the Halfmoon Town Board hereby approves and authorizes the expenditure of funds in the amount of \$7,000 by March 31, 2015 to Lakes to Locks Passage, Inc. for the copy-editing, design, fabrication and delivery of three low-profile wayside exhibits. Payment will be in two installments, the first invoice of \$3,500 on 2/27/15 for copy-editing, and the second for \$3,500 on 3/20/15 for design and fabrication. Exhibit topics include: "Why the Champlain Canal," the "Halfmoon Historic Waste Weir," and the "Farmers Bridge";

BE IT FURTHER RESOLVED that the Town Halfmoon Trails Committee and Lakes to Locks Passage will collaborate on the development of text and acquiring images, but the costs for permission and acquisition of images will be the responsibility of the Town of Halfmoon.

Supervisor Tollkisen: The other item on the agenda for myself this evening was today we had our Senior Citizen Bus Dedication ceremony. We had about 150 people there. It was a great event and the seniors had a great lunch with the Town employees, and many elected officials. I think it went really well. Thank you for those who came.
