Councilman Hotaling: One of the busses in our Senior Fleet is in some serious need of repairs. Supervisor Tollisen has worked on a program through the County to receive \$25,000 toward the purchase of a new bus. The bus that it is replacing will be sold and we should get some decent money for it. We budgeted for the full amount to not be over \$50,000. The balance of the money owed will come out of Capital Reserves.

Supervisor Tollisen: This is a bus that would replace one in the existing fleet. It is in the amount not to exceed \$50,000, although we fully expect that we will get the grant from the Saratoga County Office of the Aging in the amount of \$25,000. Once we get the bus up and running and switched out we will sell the old bus and get our best price for it. We are hoping that we will not come near the \$50,000 mark and quite frankly, will be quite low to be able to replace a bus. I will tell you that the existing bus just replaced a piece of the flooring the other day because there was a hole in the flooring. We definitely do not want any issues with respect to the safety of our seniors. Does anyone wish to be heard?

I have been attending several meeting of the Halfmoon Celebrations Committee and meeting with the Parks and Rec Directors, we have a lot going on this year in Halfmoon, a lot of great things. The Celebrations Committee has grown to over 25 people volunteering their time. We get the Halfmoon-Wateerford Fire House pitches in, Clifton Park-Halfmoon Ambulance, just hats off to everybody. It is great to see so many people in the community come together and make all of these things happen.

Rec Department is taking applications for Summer Counselors Parks Department is taking applications for the summer park workers

Supervisor Tollisen: Mr. Hotaling, an update on Character Counts program, we met with some area Not for Profits, some churches and different leaders in the community. Our first Character Counts event will be sometime in April and it will be sponsored by a joint effort of the town, YMCA, and CAPTAIN, so stay tuned for that for our kids. That's exciting.

I have two items this evening. The Ethics Committee will meet this Thursday at 7pm and the Residents Relations first meeting will be next Thursday the 13th at 7pm. Both of those meetings will be held here in town hall. Thank you.

Daphne Jordan: 1) Chair of Business and Economic Development, 2) Chair of Insurance (Liability and Medical), 3) Liaison to Open Space and Trails Committee

The Business Economic Development Committee had its 2nd meeting. The easiest thing that we could do was to start reaching out to our local Halfmoon businesses. The committee members are personally going to the businesses and doing two things. One is to invite them to be listed on our new Town Website in a business directory for the town, free of charge. Secondly, reach out to businesses because we want to hear the concerns they may have to see how the town can help them, or perhaps how the town now hinders them and how we can alleviate those hindrances. Committee members are very active in this and we are anxious to hear back from our businesses.

As far as the Insurance Committee, we will be having a resolution later, resolution #12, that I want to speak a little bit about. I want to make a recommendation to the Town Board that we purchase our health insurance through CDPHP. This plan that the committee has found, will not compromise any of the medical benefits that town employees currently receive. They will not have to switch their health care provider. When the town was looking at our initial renewal premium, it was raised 12.14% which is an increase of \$87,742 of which the town had budgeted \$70,000 in increase. What we are able to do with this plan after requesting rate relief and switching our current plan, we're able, and I am very happy to say that were are able to not even have to spend the \$70,000 that we had budgeted for increase. We will be paying less for our insurance without compromising what we have. Additional savings will be based on our utilization rate, so we stand to save a lot more. We will know this time next year exactly how much that is.

The Senior Center

The Historical Society held their monthly meeting on Feb. $25^{\rm th}$ & had a roundtable discussion on what life was like before & when televisions were first introduced. The next meeting will be held on March $25^{\rm th}$ at 7:00 pm. always something interesting.

As the Town Clerk's Office is going through our old records, we keep finding some amazing documents. This weeks "Find" was the original minutes "In the matter of laying out a central school district in the towns of Clifton Park, Halfmoon, Malta,

Waterford, Ballston and Stillwater", held on the 14th day of January, 1950 at 1:00 pm, signed by Ellis Smith, Town Clerk of Halfmoon, the start of Shenendehowa Central School. It has a listing of all of the people who helped start Shenendehowa. I have made some copies if anyone is interested.

I would like to give a quick thank you to Brenda LaMere who gave us giveaways for the seniors from the Office of the Aging. Today, the Senior Center had their monthly business meeting and they were all gone! So, thank you Brenda.

Supervisor Tollisen: Just for myself, first of all, I am very happy with the health insurance that we were able to look at a different plan that doesn't compromise the needs of our employees, but one that saves the town a considerable amount of monies. I appreciate the efforts of you Ms. Jordan.

Additionally, you will see items #9 & 10 of the agenda, that is a step that I have taken. They are necessary items for our Highway Department, but I am taking them out of the General Fund to reduce general fund expenditures and they will be coming out of Capital Reserve where they should be coming out of. I am making those changes again to work on our budget. I will continue to make those changes as we go forward through the year.

PUBLIC COMMENT (for discussion of agenda topics)

Joe Christopher, Werner Road: At the last Planning Board Meeting the Princeton Heights Subdivision passed much to the dismay of many of the residents in that area. The Planning Board member's before voting all said that they felt that the project was not in the best interest of the residents of Halfmoon, every one of them, and yet they felt their hands were tied by local laws. How does that happen? How does it get passed by the Board?

Attorney Murphy: Having been at the meeting and acting as counsel at the meeting, maybe it would be better for me to answer this question. With regards to the subdivision regulations and all of the engineering that was done with regards to that project, it all came back saying that it was in compliance with local law and would not have a negative impact that was not mitigated through the plan on the existing residents. Based on that, the board doesn't really doesn't have an option because of a personal belief that traffic may be worse, when all of the engineers say that the traffic impact has been mitigated.

Joe Christopher: I completely understand, but they felt as if their hands were tied by local law and when Mr. Ouimet presented it he began explaining it and how they had done their due diligence and the project had been back 6 or 7 times since 1995. He handed it over to you and asked you what would happen if they were to vote no on this legally and you said that because of local laws, the builder could potentially have recourse against the town because they had met all those obligations. Where you have an entire board unanimously that feel that they have to approve that project that is not in the best interest of the town, based on local law. I think that there is a problem in the system

Attorney Murphy: Just so the Board is aware for those who were not at the meeting, much of what I spoke about was not about the local laws but the engineer's reports and that they say there isn't going to be a negative impact which ties the board's hands. It went through four different engineering firms, based on requirements of the Planning Board.

Joe Christopher: I would like to hear from our elected officials if they think the process is working right.

Councilman Wasielewski: Joe, just give me a minute because I was not at the meeting and I am not familiar with the specifics. The four different engineering reports, including the town's own engineer, these weren't all paid for by the developer?

Attorney Murphy: Correct

Joe Christopher: Do you think this process is working right?

Supervisor Tollisen: I can speak for myself with respect to this project. It was a very difficult project, I tried to get informed very quickly and I spoke with some residents about it. It was a Planning Board function and was something that went on for quite some time and I am not sure what the Planning Board said, I wasn't there. I try to purposely not interfere with a separate government body because they are a separate automatous board.

Joe Christopher: You are our elected officials and you make those local laws they have to follow.

Supervisor Tollisen: That's correct. We make zoning laws and I will tell you that we are looking at those right now. I would suggest, that if you have a specific suggestion or recommendation, make sure that the Zoning Review Committee looks at this so that we can make sure that we are constantly

Joe Christopher: It is not my job to make sure that the residents feel happy and are made whole. That is your obligation. And I will tell you; the residents that live there do not feel like they were served by this board. Do you feel that they were?

Supervisor Tollisen: Again, I am going to tell you that this is not a function of the Town Board. You can argue with me if you want Joe, but unfortunately, this is a separate board. The law requires that the Planning Board be a separate, non-political body appointed to specific terms.

Joe Christopher: Their hands are tied by the local laws that you create. I have made my point. Thank you.

Larry Koniowka, 15 New Castle Road: I was given this letter to read on the same topic and read the following from Stephanie Nolet, 3 Cambridge Drive:

March 5, 2014

To Whom It May Concern:

My name is Stephanie Nolet, 3 Cambridge Avenue, and I am very disappointed by the recent approval for Princeton Heights. I understand that the land in question is zoned residential, so this was not a PDD with public benefits but merely another neighborhood going in...

I understand, as Lynn explained at the Planning Board meeting when it was passed that the town could actually be sued by the builder if they didn't approve this even though every single member of the planning board was against it, although John Higgins was the only one who actually voted against it...

What I don't understand is how it is ok for someone to completely disrupt an entire neighborhoods way of life for 4-6 years. Forget the traffic, noise and additional people we will have on our narrow, 20 foot wide roads once this is built out...

Forget that Woodin Rd, Dunsbach Rd and Stone Quarry Rd. certainly seem like they are near capacity for the infrastructure built by the town...

Forget the loss of a beautiful natural area that many enjoy in our town...

Forget the fact that the builder says there will be no storm water management issues, but the majority of the homes that surround the area in question, myself included, flood in some way whenever there is heavy rain...

4-6 years.

This is what Belmonte has said that build out time would be for this "depending on the economy."

20 foot roads that are already falling apart. Construction vehicles and construction noises for 4-6 years. I have neighbors talking about moving. I don't understand how this can be built when the ONLY way in and out of the neighborhood is through our neighborhood. Built through a community with streets that were up to standard in the 1960's, but are not now.

I understand that there is probably nothing that will be or could be done to stop this, but I just had to get my opinion on the record one more time.

Larry Koniowka: That was my neighbor Stephanie. She lives a couple of houses from me. I too, am very disappointed that it was passed. Like she said, all of the Town Board Members were against it. All of them said that even if they lived in the development that they would be against it themselves. It is just truly amazing that even though all of the members were against it, makes you wonder, who is really running the town here? Is it the developers and their lawyers threatening a lawsuit? All we were asking for was a small or downscale of what they were proposing. They have a roadway on a dead-end street going through two people's houses. There is a swimming pool on one side with a shed and a little garden with a swing set on the other side. You are going to have a roadway going through someone's backyard? Just to put in a secondary roadway on a dead-end street when a straight way would have been fine. Or if they built it two houses up where there was no houses on the other side of the other house. No, they had to go through somebodies house. I do not know those people that well. I see them at garage sales once a year. I am upset for them. It begs me to wonder if the public's opinion doesn't really matter and especially when it has been stated that these public hearings we speak at, is supposedly a privilege not a right. Why do any of us even come to these things then? It is probably why we don't have a good turnout if the public isn't being heard. I don't know if I want to join a committee if my opinion is going to be

squashed by people with money or their political affiliations. I am just very disheartened and disgruntled. Thank you.

Supervisor Tollisen: Mr. Koniowka thank you for your comments and Ms. Nolet, your letter has been placed in record in the minutes.

Stephanie Nolet, 3 Cambridge Drive: Larry read my letter. I did not know if I would be here in time for this. The one section that I added in today, is just our 20 foot road that you mentioned is already falling apart. With construction vehicles and the noises over the 4-6 years, I have actually heard neighbors talking about moving. What I really don't understand is how this can be built when the only way in and out of it is through our neighborhood. Like I said in the letter, I know how the land is zoned; I understand that, it is just the only way in and out is through such an old neighborhood that I have a problem with. Thank you.

PUBLIC COMMENT (for discussion of non-agenda items)

Kurt R. Shaner, an engineer with Waste Connections, Inc.: Our local subsidiary, the Capital Regions landfill is the contract operator for Town of Colonie Landfill. I am here tonight with Don Halek who manages the landfill and other operations in and around the Capital Region area.

On Thursday night, the Town of Colonie approved a resolution to begin and submit the EAF for an expansion of that landfill. We wanted to make the Board aware of that. That will be a long process. I am sure the SEQRA process will result in a positive declaration and there will be lots of meetings associated with that. We wanted to let you guys know that was happening. We wanted to offer that as that process proceeds, we would be happy to come and let you guys know what our plans are and how that expansion will end up. A lot of time in these projects, I think that a little up front communication goes a long way for one; getting input from local residents and two; sometimes lack of information creates misconception and problems with perception that are not true. I think by being up forward, everybody knowing what the plans are early, makes the process a little easier for everybody.

A couple of things that I will share with the project is that there are four years left in the landfill. So we are beginning this process now. The expansion isn't to change the daily operations. It is not to take more tonnage on a daily basis. It is simply to allow a continued use of the site beyond the four years in the current permit.

We are not going to take waste from other locations, it will continue to service the capital region area; Town of Halfmoon, Waterford, Cohoes and places like that. A couple of other little details; part of the plan is to establish a new entrance to the facility. It is a little cumbersome for the trucks to get out up there at the bend on Route 9 and get to speed; it is a 55 mile an hour speed zone. Traffic wise, it is not optimal. What we would like to do is to change the truck routing to get off highway 9 at Fonda Road, come down Fonda to Green Mountain and come into that little Industrial Park, so we think that allows the trucks onto highway 9 with a traffic signal. We thought it would be a little bit safer for traffic in the area.

The expansion is going to be on the property currently used for disposal. It will spread the sides a little bit and it is going to go over some areas and taking waste 30, 40 years ago. We will reuse those areas if you will. It is a more efficient us of the current parcels that currently house the landfill. So, we are not buying parcels in and around and expanding on new parcels. We are going to optimize the land that is already being utilized. I think that is the bulk of it. If there is any feedback on how you would like to receive information on this, we would love to get that at your convenience. If it is to come back at another Town Board meeting and give a short 15 minute presentation on the plan. I will say that we are still early in the process, just having started the SEQRA process, so the designs are still evolving.

Councilman Polak: Will you be opening up areas of buried garbage in those new areas?

Kurt Shaner: Not to a major degree. There are some soil covers on some areas that we will take off to reuse those soils and not waste that space. There is not going to be a large scale digging in the garbage and moving it out.

Councilman Polak: I was just wondering about the stench that comes across the river. I mean, a few years back, the phone rang off the wall because people couldn't even open their windows along Canal Road, River Road or

Kurt Shaner: We have operated the site for two years. We think that we've done pretty well in that two years. We did have a blip this past summer that was unfortunate. We took some waste from Hurricane Sandy. Typically waste decomposes basically over a two year period. That is when it starts to decompose and you start to get the odor. That waste, because how it had been handled, it had been mushed up and sat out in the rain, that added moisture enhanced the rate of decomposition and it started to smell in six months. We took that in December, January time frame and by the summer, it was already starting to go. We have since installed some trenches that are like French drains, and we put them under vacuumed and collect that gas so the gas isn't being emitted anymore. We feel that has mitigated that situation and we have more of those going in here, probably in the next month or so. We are trying to be more proactive, but that one caught us a little off guard.

Councilman Hotaling: You had commented that you had four years left on the current permit and looking to extend it. Is that the total build out?

Kurt Shaner: We have four years left on the current permit and we are looking to extend that for 20 years, depending on the engineering.

Supervisor Tollisen: Anyone else from the board?

Councilman Wasielewski: Those odors are a major cause of concern for me and for most of the residents in the southern part of town. A couple of years ago, we addressed this with the Town of Colonie when the transfer of the facility was being discussed. The fact that you are here tonight is huge to me. We look forward to working with you and I am glad that you are making these proactive steps.

Kurt Shaner: We are happy to do that, communication is key. Landfills are a little bit of an art, especially with odor control. There are tough times there and it is not always perfect, but it doesn't need to be a continual nuisance. We have done two projects at the site since we have taken over operations. We did one in 2012; we repaired some things in 2011 when we took over operations in September, 2011. As said, we have more scheduled here and hoping to start March 17th or so.

Supervisor Tollisen: What I would like to do is right after the meeting, please see my secretary Lisa, I would like to set up a meeting with you to go through this a little bit more in further detail and discuss some of our concerns. We can also set up a presentation for you to come in and notify the residents in that area as well so they can identify their concerns. Appreciate it. Thank you very much.

Kurt Shaner: Thank you.

Larry Koniowka, 15 New Castle Road: Something that I forgot to touch on before I felt the need to step away from the mike. The builder was hesitant to commit to the bondage for the damage that might occur to the roads. They really were apprehensive to commit to anything and was left open ended of what they would do. Apparently they might utilize only one entranceway into the Princeton Heights development that they are proposing. There is obviously two or three exits for that, so if they only use the one and when they do, which they will, what do we as the public have as recourse? Can we file a complaint? Will they get a finger shaking, a slap on the wrist, a hit in the wallet? I don't foresee them only utilizing the one route once they get to the other end of the development. Those roads are so narrow, windy and hilly and all of the neighbors will be in jeopardy. I just was curious, there was no resolution done at that time. He was apprehensive to commit to anything. I do not know if they did come back with anything afterwards.

Attorney Murphy: Again, for those Board members who were not at the meeting. The Planning Board made as a condition of the approval, that the developer properly bond, post a Letter of Credit actually for any damage that may occur for the roads. That very correctly stated, the developer was very hesitant to do so, for whatever his reasons were. But it was made as a condition of the approval that the Letter of Credit be established as determined by our engineers. This was just a preliminary approval, so they are not going to start doing anything until final approval, if they get final approval and that final approval will contain the details that you are looking for. And if they violate those details, it is a violation of their site plan and then Code Enforcement can site them, fine them, etc.

Larry Koniowka: OK, just wanted to make sure. Who would I file that complaint with when I start seeing lumber trucks going past my house?

Attorney Murphy: Code Enforcement

Larry Koniowka: Code Enforcement, OK

Supervisor Tollisen: You can always call my office too. Lyn, you will make sure with that final approval that the proper Letter of Credit is posted so that if there is an issue, it will be addressed by the developer.

There being no further business to discuss or resolve, on a motion by Councilman Hotaling and seconded by Councilman Wasielewski, the meeting was adjourned at 7:55 pm.
