PLEDGE OF ALLEGIANCE and MOMENT OF SILENCE

Supervisor Tollisen: Neither one of our presenters are here so I will go over some budget highlights. As the Town Board is aware, the Town relies on three major sources of revenue for the Town Budget; mortgage tax, sales tax and highway tax. Our budget for 2021 is the result of statistical data and analysis that we performed including the all-important and relevant Covid issues that we are facing. The Town has been on a spending freeze, we have cut where we can cut, we have kept things as low as possible, but for 2021, we have made a number of cuts in the Town Budget. This budget marks the 42nd year that there is no General Fund Town tax to be levied on the residents of the Town of Halfmoon. There is a budgeted raise pursuant to the 5 year plan with respect to Town employees. The 2021 budget also takes into consideration a substantial decrease of \$600,000 expected in the sales tax revenue, so we are looking at that sharp decrease. The decrease in sales tax is based upon, obviously this Covid issue and the Saratoga County Treasurer's best estimate of anticipated receipts that will be coming in from the remainder of this year and into next year. The estimate is based upon what they call the NYSIG Covid 19 Economic Impact Report which is distributed to local governments to help aid with budgeted planning. The Town is designated to use about \$100,000 of unappropriated fund balance for the 2021 General Fund portion of the budget. It is expected that while in that budget as an appropriation that we would never even use that appropriation. The Town's fiscal condition is extremely strong. We have substantial reserves built up in the General Fund, the Highway Fund and the Water Fund, which is good. The projected forecast for this year due to spending increases and with the lower revenues and the lower expectation, we are still going to be in very strong fiscal condition and I am not expecting that we will need to use any fund balance at all. So that is good.

The General Fund portion of the budget of 2021 will decrease 4.64%. With respect to the Highway portion of the budget, we are looking at a decrease of 6.23% from the 2020 budget. The Highway tax will stay within the tax cap that is allowed and required by the State of New York. What this will do, it will continue with our 20 year plan that we have in effect. We have been very hesitant and reserved with our expenditures for this year, but right now because of the projections through the end of the year and because of the savings that we have experienced, the Highway Department is working on a rather large project in Colonial Green doing some infrastructure drainage projects. Our Highway Superintendent and Deputy Highway Superintendent are here if anybody has any questions.

We are doing as much as we can do. We are trying to continue essential and critical services while maintaining fiscal responsibility. Overall, if you look at the Town Budget for 2021, the decrease is 1.93% over the whole budgetary amounts and basically we see that as a positive thing. Just so that everyone is clear, we have an independent auditing firm audit our books every year. Once again, BST & Company has issued that in all material aspect the respective financial position of the governmental activities, each major fund and the remaining fund information are

all in accordance with fair accounting practices and we are in good financial condition. Our S&P ratings are AA. The rating reflects a very strong economy. It says adequate budgetary performance which factors into our view the operating results relative to fiscal 2019, very strong budgetary flexibility, and very strong liquidity with total governmental cash available and adequate debt and contingent liability position. The good news is that 91.3% of all Town debt will retire in the next 10 years. The Town is doing well financially and again, the budget reflects some decreases taking into account very, very fiscal conservative policies due to Covid that's going to bring us through next year.

Now we will honor a very special person and I will have our Celebrations President David Maxfield come up and make a presentation.

PRESENTATION HONORING ED JORDAN – 20 YEAR VOLUNTEER FOR CELEBRATIONS COMMITTEE

David Maxfield, President Celebration Committee: David read the following:

Good Evening. My name is David Maxfield and I am also a volunteer for Halfmoon Celebrations. For those of you that do not know what Halfmoon Celebrations is, we are a not-for-profit organization run by volunteers who have the commitment to deliver free family fun events to the residents of Halfmoon and the surrounding communities. I personally have been a volunteer on this committee since 2007 and since that time, I have seen volunteers come and go, events change, some new events have been imagined & produced and some events have been tabled to try to do again someday, nonetheless one thing that has never been modified is Ed Jordan's loyalty to this Association. Ed and I have become very close friends over the past 13 years through Halfmoon Celebrations. From the time when I took over as president in 2012, Ed would always ask me, what could I do to help?

Ed & Traci always thought of safety first and to make sure that Celebrations followed the OSHA rules and regulations. I know that personally I would have been lost without Ed and his knowledge of safety.

Ed does so much more than just traffic control and safety. He attends our meetings and always has ideas to share. Ed is always right there to assist with passing out informative information about our events and even helps with decorating the Town Hall for our annual Jingle Bell Bash, Easter "Egg"Stravaganza and outdoor Harvest Festival. If you know me when we it comes to decorating, it involves masses of decorations and I do mean mass amounts of decorations that we put up.

Ed also, has been generous enough to return our bottle from our bottle drive, which assists us with funding our free events. Ed simply put, is always there to help! When I originally became president of Halfmoon Celebrations, I always wanted to thank those volunteers currently on the committee. All these volunteers give up their nights and weekends to produce amazing events to simple make others happy. I knew we needed to

simple say thank you; however, I was not sure what to do. Then I thought about, what if after 10 years a volunteer would get an award and we could recognize them for being with us for so long?

Let us be honest, a volunteer giving time back to their community for a day is great, but 10 years the volunteer ought to be recognized. Here we are again with Ed with another 10 years of volunteering for a grand total of 20 years of volunteering with Halfmoon Celebrations, its' just simply astonishing. Lastly, before you come up to accept this award, I want to also say thank you for your service to our country as a you served 2 tours in Vietnam with the Brown Water Navy and for your service to Halfmoon Celebrations and the Town of Halfmoon. I am excited to volunteer with you for many more year!
