PRESENTATION: WOODLOCH RESIDENTIAL PDD (AMENDMENT TO THE INGLEWOOD PDD)

Supervisor Tollisen: This was originally referred by the Town Board to the Planning Board and has since been sent back to the Town Board

Jason Dell, Lansing Engineering on behalf of the applicant Nine Plus Holdings, LLC

Request that an additional 7.86+ acres (5 parcels) to be added into the Inglewood PDD which was 9.1 acres (27 Townhouse units) would total 16.96 acres.

- Located 1100 feet from the intersection of Cemetery Road and Old Route 146.
- Inglewood PDD be amended, the project property be re-zoned, and Woodloch included.
- Construction of 42 single family residential homes
- Minimum lot size of 4,000 sq. ft. (40 'wide by 100' deep)
- Homes ranging from 1,200 1,400 sq. ft.
- Access off Cemetery Road (1,900 feet of road)
- Marketing first time homebuyers/retirees
- Water to the project from the existing water main on Cemetery Road
- Sewer will be provided by connecting to the Saratoga County Sewer District
- Storm Water Management will be provided according to the requirements

The proposed public benefit is to extend the sidewalk along the street to connect with the commercial area at the south end of Cemetery Road (Lawrence Circle Project) and offer \$1200.00 per unit to be used by the Town of Halfmoon Highway Department for general highway or traffic related improvements.

Jason Dell: We are here this evening to introduce this PDD amendment to the Town Board in hopes to be referred to the Planning Board

Supervisor Tollisen: Just let me clarify my comments that have been made. This would be a referral to the Planning Board if the Town Board is so inclined, but first the questions:

Supervisor Tollisen: What is the extension of the sidewalk, how long is it?

Jason Dell: The exact length would be determined as we go through the Planning Department and see where it would make the most sense with the slopes as we get to the top of the hill. We will extend that sidewalk as far as deemed necessary to the opposite side of the property where feasible

Supervisor Tollisen: Questions from the Board?

Councilman Hotaling: Jason, do you propose a HOA

Jason Dell: Yes, a HOA would be required for the sidewalk maintenance and well as for the small park ownership and maintenance as well as the ownership of the storm water management area

Councilman Hotaling: What about the road?

Jason Dell: The road would be proposed for dedication to the town. It would be designed per town standards.

Councilman Hotaling: You said that the \$1,200 per unit be to the highway fund. Is that the highway improvement fund or to the highway fund

Jason Dell: Either/or, whatever the Board or town would prefer, the applicant would be open to either.

Councilman Wasielewski: Just a couple of questions. What would be the density of the project per acre? It looks like we are going to be pretty close.

Jason Dell: With the 2 projects combined, you are a little over 4 units per acre

Councilman Wasielewski: Oh, I see because this is an amendment to the Inglewood PDD?

Jason Dell: Correct.

Councilman Wasielewski: Gotcha. So these are presumed to be owner occupied and not rented, is that right?

Jason Dell: That is correct. It is the goal to market the project to couples starting out or empty nesters.

Councilman Wasielewski: With the HOA and looking for that demographic, so would we be including lawn and snow maintenance as part of this?

Jason Dell: I would have to talk with the applicant. That is certainly a possibility and could be provided by the HOA

Councilman Wasielewski: Basements in these units?

Jason Dell: We don't have an actual house design yet, but there could certainly be basements. It would be a typical house with

Councilman Wasielewski: I know that I am getting into the actual nuts and bolts and beyond tonight's purpose. That hill that comes up by the entrance is a blind curve. Did you determine that to be the best entrance

Jason Dell: Yes. We have been looking at this property for some time now. Previously there were 2 entrances at the top of the hill and both of those locations were deemed not to be the optimal locations by the traffic engineers. Where we currently have the entrance is the optimal location right about at the top of the hill, just off of directly in front of the shared driveway across the way, but in either direction we won't be critically limited to the site distance.

Councilman Wasielewski: I did notice that second entrance there, would that be for emergency

Jason Dell: Yes, that would be for emergency purposes only.

Councilman Wasielewski: So it would not be a regular useable entrance

Jason Dell: No, just emergency purposes

Councilman Wasielewski: That's all that I have right now. Thanks

Please note that if the Board wants to schedule a public hearing that we at least need to go out 30 days for the County Planning review. So that date would need to be about January 16th.

Kevin Dailey: Supervisor Tollisen, members of the Board. When I was last here before the Board and was referred to Planning. They considered this and unanimously recommended the change to the PDD back to this Board and I am here tonight asking to schedule a public hearing. One of the things that has come up in discussion is the matter of community benefit. I want to assure the Board that we want to participate in this program and do our fair share for the town. What that will consist of and the exact degree, we can work together and determine that.

One of the things that I did want to mention that this Board put a provision in the local law that at the time of final site plan which is conferred by the Planning Board, that we need to come to the Town Board for one final review. At that point we will know the exact use, the exact scope, the size, the traffic impacts with a great deal of precision. The Planning Board will be ready to grant final site plan approval. At that point, this Board has always wanted to make sure they have the final say, the final signoff. We would have to visit you for each phase of the project before final site plan would be granted and at that time certainly any remaining business that we need to do relative to a community benefit would be dealt with.

Can I answer any questions?

Supervisor Tollisen: Can you just give a short summary of the nuts and bolts of it?

Kevin Dailey: The Board approved:

- Approved in 2008 as a Medical Campus
- Now we are seeking an additional use to allow for senior oriented housing
- Some level of care and possible approval from DOH not determined yet
- Making a site plan application to the Planning Board


