NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN that sealed proposals are sought and requested for **Contract #1** – **Construction of First Responders Memorial and Harris Road Plaza Improvements** for the Town of Halfmoon, 2 Halfmoon Town Plaza, Halfmoon, New York. 12065

Sealed proposals will be received by the Town of Halfmoon at the Office of the Town Clerk, Town Hall, 2 Halfmoon Town Plaza, Halfmoon, NY 12065, Monday, Tuesday, Thursday and Friday 8:00 am to 4:00 pm or on Wednesdays from 8:00 am to 7:00 pm or by mail until **Monday August 26th**, **2019 at 11:00 a.m**. The bids will be open at 3:00 pm or as soon thereafter as the Town of Halfmoon Town Board Agenda allows. Said bids will be publicly opened and read aloud at the Halfmoon Town Hall.

The scope of work includes construction of a First Responders Memorial Plaza, a Town Sign retaining wall and a paver plaza with a historic bell and canopy structure, and the reconstruction of a 9/11 Memorial at the Abele Memorial Park, at the intersection of NY-Route 236 and Harris Road in Clifton Park, New York 12065.

Contract No. 1 – Construction of First Responders Memorial and Harris Road Plaza Improvements, generally consisting of installation of all items in the Contract Documents including but not limited to clearing and preparing the site for construction, installation of thermal and rocked finished memorial granite, concrete pavers, landscaping, in-ground & landscape lighting, retaining walls, and pin-mounted lettering.

Contract No. 1: Alternate #1 – Light Poles and Fixtures, consisting of removal and disposal of existing pole mounted lighting, conduit and concrete bases in the project area, and installation of new light poles, pole top fixtures, concrete bases, and associated conduit.

Contract No. 1: Alternate #2 – Historic Bell Plaza and Shade Canopy, consisting of clearing and preparing the site for construction, installation of concrete pavers, canopy structure, lighting, historic bell relocation, and concrete flatwork.

Proposals shall be submitted with detailed specifications of the items proposed to be furnished on the form of proposal obtainable from the aforesaid Town Clerk, which formal proposal will contain accompanying instructions to bidders and a copy of the specifications.

Each Bid must be accompanied by a certified check in the sum of five percent (5%) of the amount of the Bid, drawn upon a national or state bank or trust company, to the order of the Town of Halfmoon, or a bond with sureties in a penal sum equal to five percent (5%) of the Bid, conditioned that if Bidder's Bid is accepted, Bidder will enter into a Contract for the same and that Bidder will execute such further security as may be required for the performance of the Contract. Separate Performance and Payment Bonds, each equal to one hundred percent (100%) of the Contract Price, will be required of the successful Bidder, and the bonds shall be satisfactory to the Town of Halfmoon counsel.

Attention of bidders is particularly called to the requirements as to conditions of employment observed and minimum wages rates to be paid under contract as determined by the New York State Department of Labor and included in Section 00 73 10.

The contract for the above items will be awarded by the Town Board to the lowest responsible bidder. In cases, where two or more responsible bidders submit identical bids as to price, the Town Board may award the contract to either of such bidders. The Town Board reserves the right to reject any or all bids or to accept any alternate proposal not significantly altering the bid specification.

No bids received may be withdrawn by any bidder for a period of thirty (30) days from the date of the bid opening.
