Sealed bids will be received by the Town Clerk, Town of Halfmoon, 2 Halfmoon Town Plaza, Halfmoon, New York 12065, until Wednesday, July 26, 2019 at 2:00 p.m., at which time they will be publicly opened and read.

The work site is located on at the intersection of U.S. Route 9 and Farm to Market Road, Town of Halfmoon, Saratoga County, New York

The work includes providing all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion the work shown on the plans and described in these specifications including, but not necessarily limited to the following installation of a turn lane, signal revisions, extension of culvert, maintenance and protection of traffic, erosion and sediment control, and restoration:

Bids received from Contractors other than those on the official Plan Holders list may not be accepted.

All bids must be made on the official Bid Form or an exact copy by reproduction thereof and enclosed in a sealed envelope. This is a lump sum bid as described in the Instructions To Bidders. No Bidder may withdraw his bid within forty five calendar days after the actual date of the opening thereof. Each bid must be accompanied by a bid security in the amount of five percent of the base bid in accordance with the Instructions To Bidders.

The successful Bidder will be required to furnish construction performance and payment bonds in the full amount of the contract price.

The successful bidder will be required to comply with all provisions of the Federal Government Equal Employment Opportunity clauses issued by the Secretary of Labor on May 21, 1968 and published in the Federal Register (41CFR Part 60-1, 33 F.2 7804).

Owner reserves the right to reject any and all Bids, to waive any and all informalities and the right to disregard all nonconforming, non-responsive or Conditional Bids.
