PRESENTATION: SENATOR DAPHNE JORDAN RECOGNIZES HALFMOON AS A PURPLE HEART TOWN

Supervisor Tollisen: Next on the agenda is Daphne Jordan who has a presentation for us, Senator.

Senator Daphne Jordan: This is probably the last time I will be presenting as Senator. I would like to say this has come full circle. In 2014 when I was a Board member, the Town of Halfmoon became a Purple Heart Community. The Purple Heart wasn't something that I thought about before. I always wanted to honor and do what we could for our veterans, but to be a Purple Heart Veteran, I never thought about it until we became a Purple Heart Community. At that time, it was Commander Dave Wallingford who was the Order of the Purple Heart and with him was our Halfmoon Town resident, veteran Ed Jordan, who was a Purple Heart recipient. The two of them really wanted to get as many Purple Heart Communities as they could. When I became Senator, Commander Wallingford came to me and said "I can't do this anymore. Will you please take over for me and see what you can do to get as many Purple Heart Communities as possible in your District and in the State." I thought that is something that I can do. I am proud to say that all 60 municipalities are Purple Heart Communities in the current 43rd Senate District, all four counties in my district are Purple Heart Counties and out of the 62 counties in NYS, there are over 40 that are now Purple Heart Counties. I am happy to say that that initiative went well, and I hope it continues and it all began here in Halfmoon. I have had this Senate proclamation dated December 31, 2019 for the Town of Halfmoon in recognizing you as being a Purple Heart Community, even before my initiative, so I wanted to make sure that I was able to deliver this to you as my last real act as being Senator. Senator Jordan read the following:

LEGISLATIVE PROCLAMATION

Recognizing The Town of Halfmoon as they become a Purple Heart Community,
honoring our nation's heroes

***WHEREAS,** Members of the Armed Services from the State of New York, who have served so valiantly and honorably in wars in which this country's freedom was at stake deserve a special salute from the New York State Senate, and the communities which comprise the noble body of this great Empire State; and*

***WHEREAS,** The people of the Town of Halfmoon have great admiration and the utmost gratitude for all men and women who have selflessly served their country and this community in the Armed Forces, especially those who have earned the Purple Heart Medal as a result of being wounded by enemy fire while engaged in combat;*

***WHEREAS,** Veterans have paid a high price for freedom by leaving their families and communities, placing themselves in harm's way in order to protect our nation; and*

***WHEREAS,** The organization now known as the "Military Order of the Purple Heart," was formed in 1932 for the protection and mutual interest of all who have received the Purple Heart Medal, and it is the only veterans service organization comprised strictly of combat veterans; and*

***WHEREAS,** The mission of the Military Order of the Purple Heart is to foster an environment of goodwill among the combat-wounded veteran members and their families, promote patriotism, support legislative initiatives, and most importantly—make sure we never forget their service to our country; and*

***WHEREAS,** Today, the Military Order of the Purple Heart is building a network of Purple Heart Highways, Counties, Cities, Towns and Institutions in a web connecting all entities with the goal of forever honoring those men and women who made the sacrifice for our freedoms and received the Purple Heart; and*

***WHEREAS,** The contributions and sacrifices of the men and women from the Town of Halfmoon who served in the Armed Forces have been vital in maintaining the freedoms and the way of life enjoyed by our citizens; and*

***WHEREAS,** By adopting a resolution dated the 2nd day of November, 2016 to become a Purple Heart Community, the Town of Halfmoon continues to display the patriotism and pride that our upstate communities have for the men and women of our Armed Forces; and*

***WHEREAS,** Many residents in the Town of Halfmoon have earned a Purple Heart Medal as they fought to defend our freedoms, and it is of the utmost importance that The Town of Halfmoon is designated as a Purple Heart Community to remember and recognize veterans who are recipients of the Purple Heart Medal; now, therefore, be it*

***PROCLAIMED,** That I, New York State Senator Daphne Jordan, am proud to commend the Town of Halfmoon as they become a Purple Heart Community to honor the service and sacrifices of our nation's heroes who were wounded or killed by the enemy while serving to protect the freedoms enjoyed by all Americans.*

We have appreciated all of your hard work, all of your effort, and you have always been there for us. You have always advocated strongly for us. It is very easy to say the words well done because that is what you have done throughout, so thank you so very much from all of us at the Town of Halfmoon.

Councilman Connors: Senator, just before you leave, I would like to say a couple words. Since we started this journey back in 2014, it's been quite a road. You had a fast track to the Senate. You are the hardest worker, you put in the hours when others don't. You are passionate, committed to everybody in your district, you put some miles on the car as I know that Phil probably has to get you a new one. You didn't do it for Daphne Jordan, you did it for every one of your constituents and every one of your municipalities that you served. I cannot thank you enough and our colleague's here on the Board cannot thank you enough for what you've done for each person that you served. I am proud to call you Senator and more importantly call you, my friend. Thank you.

Councilman Hotaling: Daphne, there is not words that can say how hard you tried. We have been blessed to have you here in Halfmoon and we will continue to have you here in Halfmoon, that is the best part. I appreciate everything that you and your staff have done for us. It's been a journey and it's been second to none. The effort has been outstanding, and I am very proud to call you, my friend. Thank you for everything.

Councilman Wasielewski: Without sounding repetitive from my colleagues, we can say that not every public official is truly a public official and servant, but you are, Daphne. Public service is what you're all about and we have seen that consistently throughout your time in elected office. Thank you so much.

Councilman Catricala: I would like to say something that has been said to me many times in my life; one door closes and another one opens. I don't know what stone you are going to step on next, but you are moving on to better things. Thank you.

RECOGNITION: JOHN HIGGINS FOR HIS 22 YEARS ON THE HALFMOON PLANNING BOARD

Supervisor Tollisen: Next, I would like to ask our Planning Board Chairman and our Director of Planning and Code Harris to come forward.

This is the 3rd presentation this evening and equally as important. Tonight, we are here to honor the hard work and service of John Higgins, a Planning Board member who has served our town in an extraordinary way. I will tell you John, 22 years of service, how do we boil that down in a couple of minutes? If you calculate 22 years, 23/24 meetings a year is over 500 meetings times the hours of each meeting. I remember being on the Planning Board and the meeting did not take 20 minutes but literally hours that you would be away from your family. John, there are no words to truly put into perspective the amount of volunteer time that you have given to this town as a Planning Board member. Think about how many different items that are on the agenda over the 500 meetings, let's say there were 10 items per agenda, you've made an impact on 5,000 projects in this town. You have made an extraordinary footprint in making and shaping the Town of Halfmoon as far as our Planning and Zoning. Your comments have always been of the utmost caliber, you've made us think harder, you've made things better, you've made the projects come out with a better result because you've questioned where it needed to be questioned, approved when appropriate and said no where you felt it was not appropriate. To have the dignity and respect that you have earned from all of us at the Town Board and from your community is beyond reproach. Because of your extraordinary service, John, and I know that you get a little stipend from the Town at the end of the year, it doesn't even pay your gas mileage, we know that.
