## PRESENTATION OF THE DONOVAN AYOTTE FIREFIGHTER OF THE YEAR AWARD TO JAKE HOULE

Supervisor Tollisen: Good evening to the Hillcrest Family and to our Firefighters and Emergency Services, and also to our retired Highway Superintendent. We are here tonight for a special proclamation, the presentation of the Donovan Ayotte Firefighter of the Year Award. I had the honor of presenting the actual award with Camille and Denny and with the entire evaluation committee at the Hillcrest Installation Banquet. We are here tonight to for a formal proclamation to award the recipient and we like to do it at Town Board meetings so that it is in the Town minutes and history forever. Whereas, on October 21, 2020, pursuant to Town Board resolution #271-2020, the Town Board of the Town of Halfmoon created the "Donovan Ayotte Firefighter of the Year Award" by Town Board resolution #271-2020, in recognition of the extraordinary service and dedication of Donovan Ayotte as a firefighter, town employee, and model example for others to follow; and

*Whereas*, this award is established as a benchmark for extraordinary service and to a firefighter in our community who excels "above and beyond" in fire services and makes our community a better place because of his or her extraordinary talents, service, and dedication; and .

*Whereas,* Jake Houle is a person who exemplifies the very characteristics of life, service and character of Donovan Ayotte; Jake is young and ambitious and has an attitude of "all in" and giving 110% every time; and

*Whereas*, Jake excelled in High School with High Honors, was a member of the National Honor Society, active in several team sports; and was Prom King at his high school prom; and

Whereas, Jake was one of Hillcrest Fire Department's Junior Firefighters; and

*Whereas,* At age 17, he signed up for Interior Firefighter Training and prior to his high school graduation, Jake was accepted at the Onondaga Community College Fire Protection Technology Program where he participated in the Taunton Fire Station bunk in program, all while carrying a full load of college courses; and

*Whereas*, in December 2021, Jake completed his certification as a New York State Emergency Medical Technician; and

*Whereas,* during his summers and school breaks, Jake worked for the Town of Halfmoon Parks and Recreation Departments, substitutes for his alma mater at the Waterford- Halfmoon School District and often bails hay at the Suchocki Farm; and

*Whereas*, due to his unique qualities, the evaluation committee unanimously recommended Jake Houle as a person worthy of distinction for the Donovan Ayotte award;
