Town of Halfmoon Zoning Board of Appeals Meeting – Monday May 1, 2017 7:00 PM

Chairman Curto called the meeting to order at 7:02 PM on Monday May 1, 2017 at the Halfmoon Town Hall with the following members present:

Members- Chairman Curto, Mr. Hansen, Mr. Burdyl, and Mr. Gemellaro Alternate Member - Mr. Koval, Mrs. Paluocci Planner - Mr. Marlow Town Attorney - Mrs. Cathy Drobny

Motion made by Mr. Burdyl and seconded Mrs. Gemellaro by that the minutes of April 3, 2017 be approved as presented. Motion was carried

Public Hearing:

Walmart Sign 1549 Route 9- Area Variance

Mr. Dan Backstrom presented the area variance application as it relates to the increase amount of signage for the existing Walmart located at 1549 Route 9. They submitted a Site Plan application and Sign application for the addition of a pick-up area on the north side of the existing building. They further discussed the need to amend their application; the building is allowed 691 SF of total signage on site. The existing signage on site is 666.68 SF, and the newly proposed signage will be a 66.76 SF (Pick-Up) sign; (2) 26.61 SF (Online Pick-Up) signs; and a 15.16 SF (Subway) sign for a total of 786.44 SF, requiring a total variances of 95.66 SF.

Mr. Burdyl asked if the Subway sign was permitted, Mr. Backstrom stated that Walmart does not regulate their tenant's signs; Mr. Marlow stated he would clarify to make sure it was permitted.

Mr. Burdyl asked if the canopy was included in the total signage calculations; Mr. Marlow stated that it was not, only the main building was included in that calculation.

Chairman Curto entered into the record a letter of support for the application.

Chairman Curto closed the Public Hearing closed at 7:15 PM

A site visit occurred on April 29, 2017

Pursuant to Article XIV Section 165-79 the following resolution was made:

- 1) Mr. Koval commented: No, there is no undesirable change; it doesn't go against the purpose of the code;
- 2) Mr. Hansen commented: No other options;
- 3) Mr. Koval commented: No, this only accounts for 11% of the total allowable signage;
- 4) Mr. Burdyl commented: No, the store environment will remain the same;
- 5) Mr. Hansen commented: No, when they built the original Walmart they could not foresee the future online pick-up and necessary signage for it.

Mr. Koval made a motion to approve the Area Variance, seconded by Mr. Gemellaro. Motion was carried.
