**Joel Bianchi from MJ Engineering:** on behalf of the applicant Beacon Homes for Creekview Estates Residential PDD along with Jeffery Gabriel of Beacon Homes

- Dorothy Pingelski property 96 acres with frontage on Upper Newtown Road.
- Located in the towns agricultural district
- Initally a conventional subdivision of 55 lots and since have made an application to the town for a PDD and yields 70 lots which is 15 lots more than what would otherwise be permitted by zoning
- Presented the map with the constraint lands along the corridor of McDonald Creek (steep slopes, wetlands, & flood plains) conservation analysis
- 50% of the parcel is green open space
- Connections to an adjacent property

**Supervisor Tollisen:** What are you proposing with that part...a trail?

**Joel Bianchi:** At this time we are not proposing anything, however we know the Board wants that. We are definitely open to connect to whatever is going on over here. I know that there have been conversations with the Trails Committee and we would like to sit down and ask what are your desires and how do we link

**Supervisor Tollisen:** With part of your approval you are willing to do that. I just want to be real clear

**Joel Bianchi:** We thought that it be better than if we proposed something, so let's commit to doing it and then sit down with the Trails Committee and develop that cohesive plan.

**Councilwoman Jordan:** I have asked that previously, so that it is on the record.

**Joel Bianchi:** So with the analysis, this is what we yield with the 96 acres. We are only developing about 56 acres of it. Everything west of McDonald Creek will be retained by the Pingelski's and the residential lots on the east side.

- Town water and County sewer and the Storm Water Management/Ponds will be owned and operated by the HOA, roadways and storm water pipes will be offered to the town
- Public Benefit \$2,000 cash per lot for general traffic transportation improvements & may go to the Rt.146 light/extending trails along the McDonald Creek Corridor with Swatling Falls for scenic viewing.

**Joel Bianchi:** Any questions of the Board or public that I can answer?

**Supervisor Tollisen** asked if there were any questions from the Board. Any questions from the public?

John Mitchell, 6 Meldon Court, Mechanicville: I represent the Trails and Open Space Committee and I am uncertain about the connections into Upper Newtown Road. We have a long range view connecting the trails from Sheldon Hills into Swatling Falls and this would be our best, first opportunity to make that happen. So, do I understand that there is a plan potentially to bring the trail from Upper Newtown Road?

**Supervisor Tollisen:** To connect with what is existing now. The expectation is, I believe at some point to come out at the Town Park

John Mitchell: In the other direction toward the Halfmoon Preserve

**Supervisor Tollisen:** The expectation is to come all the way down to the Champlain Canal at some point which is the Master Plan in the future. Connecting not only the Champlain Canal but all the way up from Hudson River Road through Upper Newtown, right up through McDonald's Creek and out to the Town Park.

John Mitchell: Going toward the Vosburgh Preserve?

**Supervisor Tollisen:** I don't know if that's been discussed as far as this project goes.

Councilwoman Jordan: No, it hasn't. That is not part of what Creekview would do.

**John Mitchell:** So there is no perceived opportunity to connect into Upper Newtown Road and the Sheldon Hills Trail Extension potential?

**Supervisor Tollisen:** I think that there is still some discussion where it comes out by Falcon Trace potentially and Sheldon Hills to kind of connect those two. I think that there is a draft there already.

**Councilwoman Jordan:** I think that it is all very nebulas right now. I think that the committee will have input when it's time.
