RESOLUTION NO. 327

Offered by Councilman Hotaling, seconded by Councilman Connors: Approved by the vote of the Board: Ayes: Tollisen, Hotaling, & Connors

WHEREAS, the Town Board of the Town of Halfmoon is cognizant of their obligation to be fiscally responsible when determining appropriate expenditure of Town funds; and

WHEREAS, the Town has consistently sought a cost effective way to insure that the Recreation Department is able to provide safe, affordable programs for the residents of the Town of Halfmoon; and

WHEREAS, the Director of Recreation has compared the costs for leasing buses for transportation for some of our programs with the costs associated with purchasing a bus for use for those programs and determined that purchasing a bus for fair market value would result in a cost savings for the Town of Halfmoon; and

WHEREAS, Auctions International has buses available on their auction site that meet the requirements of the Recreation Department; and

WHEREAS, the Recreation Department has sufficient funds remaining in their budget to purchase a bus at fair market value;

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. That the Town Supervisor may execute the documentation necessary to bid for a bus on Auctions International.
- 2. That the purchasing policy as set forth in section VII(H) of the Town of Halfmoon Employee Manual shall be waived due to the nature of the bid process with the understanding that no bid shall be made which exceeds fair market value of the bus for sale.
 - 3. That the expenditure for the bus shall be from the Recreation Department Budget.
 - 4. That this Resolution shall take effect immediately.

Supervisor Tollisen: The discussion of this item is that the town had the opportunity to bid on a bus for the Recreation Department to be used for recreation purposes for the town but it will help aid in the winter ski program and things of that nature. In our opinion it will result in significant savings to the town overall.

Councilman Hotaling: That pretty much sums it up. We have had to lease the buses from Shenendehowa. For what the cost of the lease is going to be over the next couple of years, pays for the bus. It's really a no brainer.
