Kevin J. Tollisen (Town Supervisor)

I think that everyone knows about the Colonie Landfills proposed expansion. It is on our website, alerts have been sent out and we have made some robo calls, especially to the southern section of town where it would be most affected. The Town of Colonie has submitted an application to the Department of Environmental Conservation to extend the Landfill operation for another 20 years and to expand its size by another 84 feet in height. There was a public hearing at the Shaker High School previously, and I did attend with a number of other Halfmoon residents and stating our concerns from the town level.

NYS Department of Environmental Conservation notification that a Second Legislative Public Comment Hearing for the Town of Colonie Landfill - Area 7 Development is scheduled for Tuesday October 25th at the Shaker High School auditorium, 445 Watervliet Shaker Road, Latham starting at 6:00 pm. Written Statements and comments on the application may be filed prior to, or at the hearing, but no later than the deadline for written comments, which is Tuesday, November 1, 2016.

You will see later on the agenda that we have engaged the services of Nolan & Heller, who have been our attorneys regarding the GE litigation case and the Town of Waterford case, in the not to exceed amount of \$8,000. They will be setting forth legal issues that we see with respect to the application and setting forth a formal response from the Town of Halfmoon.

Secondly, next week we have invited residents from the lower Pruyn Hill Road and Pruyn Hill development to come to an Informational Session regarding the development of the Pedestrian Safety Improvements on Pruyn Hill Road, extending from Prospect Street to the entrance to Mechanicville City School District will be held on Wednesday, October 26th at 7:00 pm at Halfmoon Town Hall. This session is an open forum.

We are working on a design project for that entire area where Mechanicville Elementary School is. It is basically from the school down to the Mechanicville line and all of the development there. What we are looking to do is to set forth a presentation to those residents that we are going to be replacing all of the water lines in that particular Pruyn Hill area. We are also going to be repaving and resurfacing all of the roads in that area next year and we are also going to be completing our sidewalk from Mechanicville to Mechanicville Schools through the Safe Routes to Schools Sidewalk Grant that we received. It is a three pronged project and we are very excited about it at the Town Board level and paid for with no public borrowing what so ever. It will give a huge boost to that area. It will also help our water system and the people who live in those neighborhoods will no longer be getting water form Mechanicville, they will actually be looped into the Halfmoon water system.
