Joe Romano from CHA addressed the Town Board and public along with Joe Grasso with these covered topics that were on a power point presentation

- Original GEIS Summary
- Working group updates to Capital Improvement Plans that were identified
- Elimination of Sanitary Sewer Costs that were part of the original GEIS
- Updated Mitigation cost schedule
- Use of Open Space funds to support Dog Park

North Halfmoon GEIS:

- Statement of findings adopted March 5, 2002
- Evaluation of cumulative impacts of development in Northern Halfmoon area
- Capital improvements identified and mitigation funds collected for:
 Water, Traffic, Sanitary Sewer, Culverts, & Open Space

We identified the status of the improvements, prioritized the improvements and updated the costs of the improvements

Supervisor Tollisen: If you could just state some highlights from the original in 2002, why we are not doing them, whether they are not needed or already done.

Joe Romano: Let's start with traffic

- Ushers Road & Tabor Road traffic signal by the railroad crossing. With the low rate of development in this area, the improvement is not anticipated
- Pruyn Hill Road & Route 146 will not happen because of the light at Vosburgh Road & Sheldon Hills

Water:

• 12" water main off Cary Road has been partially completed

Sanitary Sewer:

- Trunk sewer along southern portion of the study area, and now there is a force main along Route 146. Development has taken care of with what was previously planned for in the GEIS
- Trunk sewer along Smith and Johnson Road
- GEIS funds are no longer needed

Supervisor Tollisen: I think that it is important to underscore here that this was originally done years ago and it was expected that changes were going to be made to it. This process that the town did undertake was a 2 year process. We had several meetings along with our Director of Water Frank Tironi who has been very involved in the process. He tells us what improvements and upgrades have been made and the same with the transportation portion of it with the involvement of the Highway Superintendent John Pingelski. The Planning Department was involved and CHA

with the sewer portion of this met with the Sewer District. This is something that is the results of quite a lot of work that has come to culmination here tonight.

Joe Romano: Based on the sanitary sewer and the analysis being that GEIS funds are no longer needed to be collected in the future. The previously collected funds are available for future reallocation. The town has identified traffic as a #1 priority.

One of the draft resolutions that we have provided is a reallocation of sanitary sewer funds that have been previously collected.

Another is the update in the mitigation cost schedule. The last increase was in 2007 which was an across the board 30% increase, based on inflationary costs. Since 2007 there has been a 22% increase across the construction industry. We are proposing an increase in the fees for water, culverts, traffic and open space and removal of future collection of sanitary sewer costs.

2002, the applicant paid \$2,894 per unit 2007, the applicant paid \$3,766 per unit 2017, the applicant would pay \$3,635 per unit as there would be a reduction in fees for the elimination of fees for sanitary sewer.

Our recommendation would be that we re-evaluate the fees every 2 years.

The third draft resolution has to do with the use of the Open Space Funds portion of the GEIS. Currently there is \$140,160. The town has identified a need for a Dog Park. The third resolution that we have prepared is to utilize funds for 40% of the costs of the Dog Park that will be serving the entire town.

To summarize the draft resolutions:

- Updated mitigation costs to include a 22% increase and elimination of the sanitary sewer fund
- Reallocation of the previously collected sanitary sewer funds to transportation fund
- Use of the Open Space funds for the Dog Park

Supervisor Tollisen: I will open it up for questions from the Town Board? Are there any questions from the public?

Jim Bold, Harris Road: I don't have a whole lot to say here but I would be remiss if I did not come up and speak because I am probably the one person in the room who has the most blood, sweat and tears that went into this original plan. It wasn't easy, folks. We were starting with a blank piece of paper and a committee and you can imagine that we did not all agree at times. There were many times as Chairperson that I would have to say to the committee that you have to compromise, we have to settle on something. This subject was so controversial 15-16 years ago, and we had to work very hard to get this program hammered out. When I look at the changes that you are making today, I am going to complain about one thing and that is the Dog Park, it is not open space preservation. It is like saying that you are going to take money out of Open Space Preservation and build a ball field. If that is what you choose, OK then I am done complaining. The things that you are proposing here, I am looking at them these many years later and saying wow, you are not proposing much of a change from our original document. The only question that I want to ask is you spoke about taking a review about every two years and I understand that, but it its expensive. Is there any way to build in an inflationary impact on the mitigation fees and not spend the high engineering dollars and I'm sorry Joe's, but can you do the engineering on a less frequent basis?

Attorney Murphy: The Board had lengthy discussions about what to look at with regards to the cost increase. It may not involve an entire engineering review. More likely it is going to be based on what Joe just mentioned the indices for construction costs, so not relooking at the entire document every two years and reevaluating the engineering every two years, but making sure that the fees keep up with the engineering that has already been established every two years.

Jim Bold: You're really looking at construction inflationary costs which is not a big program

Attorney Murphy: Correct

Jim Bold: Well that is all the old guy has to say!

Supervisor Tollisen: Well we can say it from this Board that you did a good job when this all started. The changes that have been proposed here, I call it reprioritizations based upon what has happened in the northern part of town. They are not significant but it took us a good year and a half, almost two years to get this document to where it is today. I think that you had the harder chore and it still took probably as long to get to be here today.

Jim Bold: I wasn't given two years for the whole thing from scratch! The sanitary sewer, we knew when we put that in that we were not sure if we are ever going to build that big trunk line.

Supervisor Tollisen: That was an issue that we really studied pretty hard whether to keep that in there or not. Based upon the conversations our engineers had with the sewer district and the non-need that's there, the town really isn't in the sewer business. Not identifying something that's a major significance to the entire northern area, that is why we came up with this.

Jim Bold: As you know, I'm just coming off of sixteen years on the sewer commission and I have no disagreement. I support what you are proposing.

Supervisor Tollisen: I am sure that Paul will be calling you for some advice. Mr. Hotaling is the new Commissioner for the Sewer District for the Town of Halfmoon.

John Higgins, 31 Cary Road: Happy New Year. As the Planning Board representative for the Northern GEIS seventeen years ago along with Jim, I was involved and I agree with Jim 100%. I think looking back we did a pretty damn good job considering what we were dealing with and what we had to deal with at that time. We didn't always agree on everything but overall I definitely think that we gave the town something to be proud of with the document that we presented and over the years it looks like it really worked.

The one topic that I want to talk about tonight was part of the traffic issues was the realignment of Cary Road out to Farm to Market. We talked about it seventeen years ago so it is no surprise, I knew it was coming. John Pingelski has given a draft drawing of what was proposed. I have 535 feet on Smith Road that I am going to lose because of the realignment and that is part of my neighborhood business district. Way back when, we talked about it and Mike Bianchino, who is no longer with Clough, and there was some discussion about taking the piece of property that is going to be on my side of the realignment and adding it to my property basically because I am losing 535 feet of road frontage. At this point there are still no designs set and I think that Clough is still working on the basic design on that. They are talking to all of the neighbors and trying to figure out what is going to work out best for the neighbors as well as the whole area that feeds into there. I just wanted to go on record obviously with the piece of property, the road frontage that I am losing; I would like the Town Board to consider taking that piece of property which is going

to be on my side and just adding it into my property on that side of Cary Road so I am not losing my frontage on Smith Road.

I can send a formal request or in form of an e-mail even or if this is sufficient just asking that we be considered when and if the alignment is approved.

Supervisor Tollisen: We will definitely look into it and I will refer that to our Town Attorney's office to research that and circle back with you on that.

John Higgins: Exactly, and again, as Jim said, I think we are proud of what we did seventeen years ago and it has worked into a document that the town has been able to utilize and refer back to over the years and for years to come.

Supervisor Tollisen: Absolutely, thank you very much for your assistance with this as well.

John Higgins: No problem, thank you.

Supervisor Tollisen: Any other questions? Hearing none, I am closing the public hearing

WHEREAS, as a result of sewer system improvements constructed by the Saratoga County Sewer District, the sewer system improvements constructed by private developers to serve specific development projects, and through changes in development patterns within the study area from those originally identified in the GEIS, the sewer system improvements identified in the GEIS are no longer required to address the cumulative impacts of development within the GEIS study area; and

WHEREAS, as a result of the above it has not been necessary to utilize the mitigation fees collected for the construction of any sewer improvements identified in the Statement of

Findings, nor is it anticipated that the collection of future funds will be required to address the future impacts of growth in the GEIS study area on sanitary sewer facilities; and

WHEREAS, the Town wishes to revise the mitigation fee schedule by discontinuing the collection of funds for sanitary sew+er improvements.

WHEREAS, as development has continued there has been additional impacts on both open space and recreational resources, both within the study area and on Town-wide facilities that are located throughout the Town of Halfmoon; and

WHEREAS, since the original date of the GEIS, the Town has identified the need for a dog park to support the residential growth in the Town, including the study area; and

WHEREAS, while a dog park can be considered a regional facility that could be located anywhere within the Town of Halfmoon and provide appreciable benefit to residents of the study area, the

most appropriate location for the dog park based on availability of sites and greatest town-wide need may be sites not specifically located within the study area; and

WHEREAS, the Northern Halfmoon GEIS study area includes approximately 40% of the land area of the Town of Halfmoon and the Town has determined that 40% appropriately represents the GEIS study area's fair share of the cost of a dog park facility that serves the entire Town.

NOW, THEREFORE BE IT RESOLVED THAT, the Town shall allocate funds from the GEIS

open space fund towards the construction of a dog park; and

BE IT FURTHER RESOLVED THAT, if the dog park facility will be located outside of the study area and be a town-wide facility, the use of these funds shall not exceed 40% of the total cost of the facility.

Supervisor Tollisen: I am not really going to get into too much of a state of the town this evening with respect to the budget for 2016. Our expectations of the 2016 budget as far as our budgeted amounts for sales tax and mortgage tax, while I do not have the final sales tax figure for December yet, understand that our budget has been met for mortgage tax and in my opinion will be met for sales tax. We are well over the conservative budget amount. We had a very good year with respect to the town and the financial condition of the town continues to be on the plus side. I appreciate all of the staff, the department managers and all of the work that they do because I rely on them very heavily to make sure that they stay within their budget and keep within the expenses that they are supposed to. That is good news for the town. I did report at the last meeting that the Moody's investment summary report for the town shows that the town's financial condition is improving and our reserves are meeting our expectations. We hope that will continue.

2017, that remains to be seen but I do expect that the trends will continue in a very conservative budget that we have prepared. While the budget did increase, it was an expected increase with the highway improvements that we decided to go forward with the 20 year highway plan. We expected the water fund to increase and that was because EPA stopped reimbursing the town due to the dredging ending. While those two items show a large increase in the 2017 budget, they were expected increases and while I still see some volatility in the water fund next year, I do see that the highway fund should flatten out. All in all I think that it was a good year for the town and I think that we have implemented more costs savings across the board, I appreciate all of the staff and the Department Managers for all of their hard work.
