PRESENTATION: TABOR ROAD FLEX & TRUCK TERMINAL PARK – AMENDMENT TO COUNTY WASTE PDD

Jason Dell, Lansing Engineering: I am here this evening on behalf of the applicant for the Tabor Road Flex & Truck Terminal Park, amendment to the County Waste PDD. Our goal for this evening is to present the project to the Board with the hope that the Board will forward the project along to the Planning Board for a review and a recommendation. The project consists of amending the existing County Waste PDD to include the property located at 12 Tabor Road. It has 6.75 acres and due to the proximity to the property to the County Waste PDD and the potential cinergy of the applications development objectives with the existing PDD, the zone change is requested.

Overview:

- Located at 12 Tabor Road with approximately 6.75 acres
- Zoned as part of the LIC zone. All of the properties in that area with the exception of the County Waste PDD are all zoned as part of the LIC zone
- Various use & tenants in accordance with the LIC & the County Waste PDD

5 Flex Buildings:

- Building #1 11,200 square feet
- Building #2 10,000 square feet
- Building #3 7,700 square feet
- Building #4&5 8,800 square feet each

Overview Cont.

- Loading docks & overhead doors for the various uses
- One access into the park via Tabor Road with parking meeting town requirements and configured for truck access
- No outdoor storage of equipment
- Meets the 20% green space requirements with 36% green space
- Each new business would have to go before the Planning Board

Utilities:

- Connecting to the existing Saratoga County Sewer line
- Storm water on site per state and local requirements
- Connecting and extending the water line from Tabor Road

Public Benefit:

- 12" Water main down Tabor Road from where it currently terminates (1,800 feet was done by the Paar Estates public benefit) we will continue the remaining 4,600 feet to the project
- Estimated cost \$552,000

Councilman Hotaling: Does the deadline still stay the same?

Attorney Murphy: No, it would be 6 months further. The way they are staggered at this point, they are divided by 4 at \$48,750 each payment and before the stamping of the plans. Then 6 months from the stamping of the plans, a year from the stamping of the plans and then 18 months from the stamping of the plans. It was staggered at \$65,000 per payment without that last 18 month period. The developer is asking this in conjunction with the public benefit with putting in the Tabor Road water line which he has already put in but hasn't constructed the project yet.

Councilman Hotaling: OK. Final C/O or anything would not be submitted until after this was paid for

Attorney Murphy: We did the original agreement that way and we are doing this one this way because if we do it based on final C/O and not that this developer would ever do this, but he could just not do that final C/O and we would not get the payment so we are not doing it based on build out, we are doing it based on time.

Councilman Hotaling: But the project would be completed and he would still owe the fees.

Attorney Murphy: Correct, might be or might not be.

Councilwoman Jordan: But that's OK because he is bound by the date no matter.

Attorney Murphy: Right, he is bound by the date. He has already invested whatever the amount was for the water line.

Supervisor Tollisen: This has already been approved by the Director of Water

Attorney Murphy: Absolutely.
