PRESENTATION: SARATOGA ECONOMIC DEVELOPMENT CORPRATION INDUSTRIAL PARK PDD

John Montagne from Greenman and Pederman along with Chuck Dunham, Branch Manager, from Graybar Electric presenting.

John Montagne: Graybar Electric is looking at the one remaining lot that is in the Saratoga Economic Development Corporation PDD.

- SEDC PDD was adopted 31 years in 1986 and I think one of the oldest PDD's in the town.
- It was set up to attract both manufacturing & light industrial use to the town

Chuck Dunham: Each Board member was handed a brochure about Graybar Electric

- Company started in 1869 and is a Fortune 500 company that is employee owned employing 8,500 people in 300 locations and also in Albany since 1929
- Wholesale only with Global Foundries as a large contributor
- Current location on Church St. since 1968 with 25,000 sq feet and out of room and proposing 40,000
- Proximity to the Northway and north of Albany is the place to be

Supervisor Tollisen: How many employees do you expect to have here in Halfmoon? What kind of traffic do you expect? Yours is the type of business that we want.

Chuck Dunham: 38, we would move the entire staff from Albany here. We have 3 box trucks on the road constantly. On a busy day we might have 6-8 tractor trailers dropping off product. UPS is there on a daily basis picking up. I can't see a large change in traffic.

John Montagne:

- The PDD we are looking at has a 200 foot set back from Route 146, similar to lot #10 that the SAAB dealership moved to and is now Grace Church
- The first amendment in 1997 changed that set back from 200 feet to 70 feet
- 2004 the SAAB dealership amended the PDD for commercial use
- The Public Benefit was the economic benefit of the projects themselves, no monetary contributions, just build the realignment of Werner Road
- When Grace Church came, a Not for Profit, they contributed \$25,000 to the General Parks and Recreation Fund to the town. We are unclear where we stand for Public Benefit now
- Graybar is coming with a taxable entity, bringing new employees and expansion in the future
- We are looking for 150 foot setback instead of 200 feet & 50 foot setback for parking
- 32,000 sq ft now with 24,000 future expansion totaling 67,000 & 40,000 now

Supervisor Tollisen: The box trucks and tractor trailers, where do they come in and unload and where do they stay at night?

John Montagne: Everything happens on the Route 146 side of the building. There is a large wooden buffer and will supplement with additional landscaping. There are no service doors or deliveries in the back of the building

Supervisor Tollisen: With the distribution doors toward Route 146, are we going to see much of the distribution going on?

John Montagne: No, I don't think that you will see much of anything going on. We are preserving the mature trees that are there and are 50 -75 feet in height and supplement as the Planning Board and this Board see fit.

Supervisor Tollisen: This is a type of business that we want in Halfmoon and this is a good project, I just want to make sure that we are not seeing the trucks lines up across the project. It is not the most desirable view

John Montagne: The building itself is 34 feet above the surface. We are going to be cutting the site down 10 feet and now will make the building only 24 feet and you will have the mature trees also.

Councilman Hotaling: How about the storm water

John Montagne: Yes, we have a storm water basin here and an underground storage system here (John referred to the map and showed the storm water system)

Councilman Wasielewski: Getting back to aesthetics, will you be storing cable reels etc. outdoors that would be visible from the road?

John Montagne: There is a planned storage area. If it is not suitable outside, it can be stored inside. We are going from 18,000 sq. ft. to 32,000 sq. ft.

Councilman Wasielewski: We do have residents along that line. They don't want to see that. Is this a 5 day a week operation?

Chuck Dunham: It is a 24/7 but the office is a 5 day.

Supervisor Tollisen: What time do the tractor trailers usually come in?

Chuck Dunham: Anytime between 8 & 3. The counter usually opens at 6

Councilman Connors: Were there any incidents or violations from the City of Albany for your corporation?

Chuck Dunham: No, I have with Graybar since 1981, no.

Councilman Hotaling: You may want to consider inside storage for the houses to the east looking down at the project.

Chuck Dunham: Yes, fine.

Supervisor Tollisen: Just so we are clear, there is no further public benefit being offered

John Montagne: Because of the history of this PDD and the only monetary one given so far is the \$25,000 from Grace Church, we would like to stay within that line because of the expense of moving here from Albany.

Supervisor Tollisen: I think that the Board may have enough to refer this to the Planning Board?

PRESENTATION: CREEKVIEW ESTATES PLANNED DEVELOPMENT DISTRICT

Joel Bianchi with MJ Engineering here tonight representing Leece Development. Mr. Leece could not make it here this evening. We are here to present the Creekview Estates PDD:

- ¼ mile east of Route 146 on Upper Newtown Road, the Pingelski Family farm
- 95 acres of constrained land including McDonald Creek with wetlands, flood plains & steep slopes that splits the property in half that we had to work with
- 70 proposed lots, minimum lot size of 10,500 sq. ft. and some above that.
- 27 acres of open space = 49% of the parcel
- Public water & public sewer through Swatling Falls
- Originally Conventional Subdivision with 55 lots and 20,000 sq. ft. lots
- Holdup on this project I think is the traffic onto Route 146 which the solution is starting to be worked on
- Connectivity to other projects
- Offering Public Benefit of \$2,000 per lot for highway improvements
- Seeking referral to the Plannig Board

Councilman Hotaling: What size houses do you propose to build?

Joel Bianchi: These are similar to what Chris Abele did: 1,200 to 1,500 sq. ft. and mostly single story and not McMansions

Councilman Hotaling: I was just concerned because you are going to 10,500 foot boxes.

Joel Bianchi: It is going to be deliberately smaller

Councilwoman Jordan: The Open Space and Trails Committee have been working with Mr. Leece about a trail going along McDonald's Creek in Swatling Falls. We know what is going to happen in Swatling Falls and there is going to be some connectivity through here and so

Joel Bianchi: Mr. Lecce is offering it up; we want to have collaboration. We don't want to go ahead and start planning stuff. If there is an interest, then we can sit down and what we can collaborate on.

Councilwoman Jordan: We have expressed interest in this.

Supervisor Tollisen: The \$2,000 a lot, that is for the intersection that you are talking about for the highway fund toward the improvements to the intersection

Joel Bianchi: If the town chooses to do that, yes. The public benefit is the \$2,000 per lot.

Supervisor Tollisen: You had talked about the discussion about the highway and the traffic and I just wanted to be clear that it is for the intersection improvements that would take place at a future time. You are not proposing anything different

Joel Bianchi: Correct.

Councilman Wasielewski: We have had the Betts Farm proposal before us both here and at the Planning Board level and those maps show possible connectivity from the Betts Farm project to this project. I don't see that on here.

Joel Bianchi: What has happened is that we may have submitted prior to them. We may just not have caught up to them. We have had discussions with Chris Abele and we and Mr. Leece are aware of it and we are going to work together. We know about that.

Councilman Wasielewski: So the answer is yes, this can connect to the Betts Farm

Joel Bianchi: There is a very strong possibility

Councilman Wasielewski: 200 cars a day could be going through Betts Farm to Hayner Road.

Joel Bianchi: Potentially, yes.

Councilman Wasielewski: OK

Supervisor Tollisen: Does the Board have enough information to refer this?

Councilman Hotaling: You are utilizing the sewer pump station in Swatling Falls?

Joel Bianchi: That would be our plan. We had discussion with the County Sewer

Councilman Hotaling: You have Glen Meadows, Swatling Falls and this project all going to the one station

Joel Bianchi: We expect there to be some improvements that will need to be done.
