Planning Board Workshop – Open to the Public – Conference Room – 6:00 PM Minutes - December 8, 2014 – APPROVED

### **Public Hearings:**

- 14.120 Lands of Sabourin, 29 & 33 Church Hill Road Minor Subdivision (Lot Line Adjustment)
  - APPROVED. A Public Hearing was held and the Board approved a Lot Line Adjustment between two existing lots.
- 14.144 Ballard Subdivision, Lot 15 Smith Road- Minor Subdivision (Lot-Line Adjustment)
  - APPROVED. A Public Hearing was held and the Board approved a Lot Line Adjustment between two existing lots.

#### New Business:

- 15.001 Jack Byrne Quick Lane, 1003 Hudson River Road Sign(s)
  - APPROVED. The Board approved five new wall-mounted business signs for the existing Jack Byrne "Quick Lane" service center.
- 15.002 Lands of Joseph N. & Terry A. Bedard, 167 Harris Road Minor Subdivision
  - TABLED. The Board tabled the proposed four lot Minor Subdivision, pending review by the fire department and Saratoga County.
- 15.003 1 Birchwood Drive Site Plan, 1 Birchwood Drive Site Plan
  - DENIED. The Board denied the Site Plan application for a 1,934 SF retail boutique due to the failure of the project to meet minimum area-related requirements of the Town Code.
- 15.004 Ushers Machine & Tool Co. Inc., 180 Ushers Road Addition to Site Plan
  - DENIED. The Board denied the Addition to Site Plan application for a 2,300 SF office space addition to the existing machine shop facility due to the failure of the project to meet minimum area-related requirements of the Town Code.
- 15.005 Stone Management, 420 Hudson River Road Change of Tenant & Sign
  - APPROVED. The Board approved the Change of Tenant and Sign applications to utilize 37,500 SF space in an existing facility (former Yankee One Dollar; shared with Fred's Tents) for warehouse purposes, with conditions related to restrictions on overnight tractor trailer parking and the location of the monument sign.
- 15.006 Hoss's Tavern & Marina LLC, 32 Clamsteam Road- Change of Tenant & Sign
  - APPROVED. The Board approved the Change of Tenant and Sign applications for a restaurant and marina facility at the site of the former Klamsteam Tavern & Marina.
