of Half Moon Saratoga County

sworn Says that he was the Assessor  
in district No 2 of said Town of Half-  
Moon in said County and State  
aforesaid during the years 1871, 1872  
1873, 1874 & 1875 and as such assessor  
did assess the Real Estate of Harmon  
J. Weber a resident of said district  
in manner following 1871 the sum  
of Two Thousand Dollars and each  
successive year thereafter the sum of  
Eighteen Hundred Dollars each year  
and no more, and upon information  
and belief this deponent believes  
that the said Harmon J. Weber  
did pay and erroneous tax of  
one thousand in excess of his <sup>lawful</sup> assess-  
ment and this deponent believes  
this erroneous assessment was made  
in the year 1872 or 1873 by the  
person or persons who copied said  
assessment roll. and that the said  
Harmon J. Weber never was assessed  
upon any personal property during  
said years aforesaid
