Supervisor Tollisen asked if anyone wanted the Public Hearing Notice read. Hearing from no one he opened the Public Hearing at

Supervisor Tollisen asked Mr. Dailey to come up and give a brief overview of your project again with public benefit.

Kevin Dailey: Supervisor Tollisen and members of the Town Board, good evening. I am representing Boni Enterprise and Larry Boni is here with me this evening. We are here for the Halfmoon Health care Campus:

The Board approved:

- Approved in 2008 as a Medical Campus and renewed in 2015
- Now we are seeking an additional use to allow for senior housing in addition to the various medical uses
- Envisioning some type of assisted living senior housing
- Low impact in the community: no children for schooling, little water & sewer & doesn't have much of an impact in terms of traffic flow
- It fits a senior housing need as our population is getting older
- We humbly request your approval of the changes in the uses in the PDD

Thank you

Supervisor Tollisen: Just to be clear, Mr. Dailey, the request is to add the use, not to necessarily remove the other uses.

Kevin Dailey: It would be to add the use, correct, an additional allowed use in the PDD.

Supervisor Tollisen: With that use as senior housing, how are you going to classify that as senior housing and insure that it is in fact senior housing?

Kevin Dailey: It will be restricted to 55+

Supervisor Tollisen: Any more questions of the Board?

Councilman Hotaling: When you say 55+, do you mean term care

Kevin Dailey: Paul, at this point, we haven't done.... there is a study that we will spend the money on, it's an expensive study and it will tell us of the senior housing needs of the community today, and in the next several years. John asked me several questions similar recently and said will this be assisted living, memory care loss, what exactly are you planning and my answer was that we don't know exactly. We expect some level of assistance in some aspect of this. Generally, when I say 55+ the reality is that it will be most likely 75+. Some may be in very good health, but we may need some level of care and some level of care and possible approval from DOH. We are prepared for that, but we didn't want to go out and spend the money on the

studies and basically find out what we need to do in terms of licensing until we knew whether the Town Board would be in favor of this kind of housing in the town and proceed forward.

Now, if you change the zoning as a result of this public hearing, we still have to come back to the Planning Board for Site Plan Approval. The PDD specifies that we need to revisit the Town Board in terms of a final sign off on the site plan before we can get a building permit. So, you will see this again with much more definition and we will be able to pin down and define the use much more precisely.

Tonight, we are just looking for the additional wording to go into the PDD so that it would at least open up the door so that we could make an application for site plan approval.

Supervisor Tollisen: I think that there is a tremendous need in our community for additional senior type housing. Two of the big complexes that we have here; Bishop Hubbard and Marina Woods, my understanding is that they have long waiting list to get into those places. They are great places to live. Any questions of the rest of the Board?

Kevin Dailey: Kevin if I could, I have seen some demographic studies in terms of where the census is going to go and there is a population bomb coming in our communities and will all hit 55+ almost simultaneously. They like our towns, why shouldn't they, but we really are not prepared for the kind of housing that they will be demanding.

Supervisor Tollisen: In my remarks at the county recently, the biggest population growth is 55 and older. The 2020 census projected that 1/3 of the population of the residents of Saratoga County will be 55+. Certainly that demand is there.

Councilman Wasielewski: I will reserve further comment until we have more details, but I like the overall concept

Kevin Dailey: Let me revisit one other thing; this particular project is geared toward people who are already residents of the Town of Halfmoon, your constituents, the people who have lived here all of their lives. If you are a wealthy person, you can go to Coburg Village which is an expensive place. If you are an average citizen, there really isn't anything in Southern Saratoga County for you as you get older. We are trying to fill that niche for middle income people who already live here. We are trying to adjust our rents for the middle class and provide them with a good place to live in a good location. We are not trying to have something for outsiders; we are trying to build something for people who already live here and that has always been our intention. I wanted to make that a point of emphasis.

Supervisor Tollisen: Any other questions of the Board?

Supervisor Tollisen: Any other questions from the public?

Supervisor Tollisen: Hearing none, I am going to close the public hearing.
