Supervisor Tollisen: Just one quick report to the Board, we are waiting for the sales tax numbers. Obviously everyone knows that the town is on a spending freeze. I will note that one positive point is mortgage tax is continuing to exceed budget expectations. We just got a report in today for last month, we are on target and potentially we can make up some ground with the loss of revenue of sales tax. It is not going to balance it but between the spending freeze and the mortgage tax, we are trying to offset it as much as possible. Mortgage tax is still looking good.

PUBLIC COMMENT (for discussion of non-agenda items)

Ed Kilmartin, 116 Staniak Road: I want to address an item related to the recent installation of water that was placed down Staniak Road and up Cary Road in relation to construction housing project. I had contacted the neighbor at 151 Cary Road who entered into an agreement with the company who completed the construction, Carver Construction to place, and I'm not a builder but looks like thousands of tons of fill on the land and the property behind my home. I contacted the Town Water Department, and I have never been treated with nothing but respect from individuals from the Town, I love this town and very happy that we moved here in 2008, and Frank was nothing but polite and respectful. The conversations that I had with him got me in contact with Carver Construction. There is a drainage ditch that runs from 151 through my yard and exits at the corner of Cary & Staniak Road. Due to the fill that was placed there, there were no barriers or protection from silt and deposit from flowing down (he has pictures from various dates). I was unaware of the activity going on and stopped at that address to talk with the contractor about where they were going to be placing the water line to my home. I know that the Town was aware that the fill was going in there because there were Town trucks stopping there periodically and the Town told me to stop there at that location when I asked where to have my water line placed. I spoke with Frank Tironi this past fall and was led to believe that there was something that they could work out with Carver Construction to help remove the fill/silt that has deposited within the drainage area, which is now completely filled. Carver Construction did recognize in the spring of 2019 that silt and deposit had built up in the drainage area behind my home. They did bring a backhoe in and dug about 6' back and refused to go back any further although the head of the site program recognized that it was silt coming from that area. He said that they couldn't bring their trucks back any farther. They dug about a 6' trench, put a water barrier down, put some rip raft down and then put a couple silt barriers down. With rains that have occurred, our property has now flooded on at least four occasions, my basement has flooded on two of those occasions. It has washed out my kids swing set and parts of my lawn. I feel bad because the Town has been nothing but good to me and they always do a wonderful job, but I am asking for some assistance. I don't have heavy equipment, I have talked to the neighbor who initially agreed he would take care of it and rectify the situation. I talked to the individual again (does not mention names to respect his privacy) but he said that he wasn't going to build a dam or anything like that, but I need some way to control the silt that continues to flow. There is a large buildup of silt, the barriers that were placed in there were like wrapped up straw that were placed before the culvert pipe. Those are now over filled with silt. The issue with the fill that is there now and I understand that someone has the ability to improve their land and make it usable and I respect that but the water doesn't have the ability to drain and collect the silt and the deposit from construction was placed and packed there and there were no steps taken to limit the silt flow from that. Over the course of many months, silt flowed down there and filled my entire drainage area. So really, before I was aware of the problem in April of 2019 we have had four torrents of water flowing through my yard. I worked extremely hard to improve the property as a good resident should.

Supervisor Tollisen: Mr. Kilmartin, obviously, this is going to require us to do some investigation, so if you could leave me your phone number, we will reach out tomorrow and get somebody out there to look at that and see what's going on and see if the Town is able to help.

Ed Kilmartin: Alright. Thank you very much.

There being no further business to discuss or resolve, on a motion by Councilman Connors and seconded by Councilman Wasielewski, the meeting was adjourned at 7:38 pm.
