#### TOWN BOARD RESOLUTION

**WHEREAS,** it has come to the attention of the Town Board of the Town of Halfmoon that Wilfred (Willy) Petuske, Jr. is celebrating his ninetieth birthday on June 17, 2018, born in 1928 to Wilfred and Olga Petuske at home in Maplewood, Village of Watervliet; and

**WHEREAS**, the family moved to Halfmoon where Willy grew up on the family farm on Church Hill Road, where Willy worked alongside his family growing produce that was sold at the family farm stand and delivered throughout the area; and

**WHEREAS**, Willy joined the C.S. Hawley Chemical Company, now known as the Halfmoon-Waterford Fire District, at the age of 16 as a firefighter, where he currently remains a life member with 74 years of service to our community; and

**WHEREAS,** Willy met the love of his life, Ruth, while attending the red brick school on Church Hill Road, attending many social events at the Grange, which, like Willy, is still standing; and

#### PUBLIC HEARING: MOTT ORCHARD PDD RE-OPENED

Deputy Town Attorney recused herself

Supervisor Tollisen asked if anyone wanted the Public Hearing read. Hearing from no one he re-opened the Public Hearing at:

OPENED: 7:12 pm

Joel Bianchi, with MJ Engineering: As the Supervisor indicated, we were here a couple of weeks ago and we heard comments from the public hearing. We have provided revisions to the plan addressing some of those comments. The comments that we heard were examining the elimination of the connection to Howland Park to the north. We're looking to eliminate the stub street to the property adjacent to the west of the north parcel, insuring the storm water impact to the adjacent properties and the traffic related to the property.

What we have done: on the Howland Park PDD, we have proposed/offered an alternate connection, it would not be a through street, but it would be a combination pedestrian path and a multi-use trail. The green highlighted area shows the existing wooded area that would remain if we were to do that work. If we move ourselves to the right, the plan that we originally showed a stub street to the property to the west and we basically eliminated that and just rearranged the lots slightly. The tree line that is along the properties would be preserved.

The other changes that we did were we rearranged the lot layout but the lot count did not change. The other thing that was ancillary to the change was that the prior plan had trails that sort of meandered through the back yards of lots, so what we have done is proposed to do a multi-use trail out on the right-away. I think that it provides much more defined access from the south property to the north property connecting to Howland Park. That is all just pedestrian paths, it is not sidewalks. On the storm water, again, we have done an analysis that the town engineer had looked at and had the same opinion that it would not result in any adverse impacts, however with the change in the connection to Howland Park to the north, we had a storm water feature there that was only serving that section of the road and now we

wouldn't need that anymore because that road is not there so the only storm water feature that would be left is on the west side of the property out on Farm to Market Road and that would discharge to the county road.

So with that, I believe that we have brought up and have been responsive to the comments that were made. I do think that on that connection to the north, I think that our prior proposal would have been in tune with good planning, the town was looking toward that connection, but we wanted to be responsive to the comments and would seek any input from the Board and the public.

**Supervisor Tollisen:** Any questions from the Board?

**Councilman Wasielewski:** Just for the record, have we heard from the Hillcrest Fire Chief on this matter an his opinion of the closing off of the second access road?

Supervisor Tollisen: We have not yet.

Rich Harris: We have sent it to him and the county will meet in a couple of weeks.

**Councilman Wasielewski:** Just for clarification, the yellow line is now the walking trail?

Joel Bianchi: Yes.

**Supervisor Tollisen:** Any questions from the public?

Dan Hoyt, 205 Farm to Market Road: I am very pleased with the taking out of the future access road towards our property, I appreciate that a lot. I found some family photos of when Prospect Meadows & Summit Hills went in about 15-20 years ago and there is a lot of run off that ran off towards our property. (Showed the Board the pictures) I would like to prevent as much of that from happening again.

Another concern is the people from Summit Hills/Prospect Meadows wandering on our family property and concerned about being sued, maybe some signs or fencing would help.

Mike Hutchins, 7 Gorseline Drive: I spoke at the last meeting to oppose the stub road going into Howland Park and gave several reasons. I want to say that I think you guys did everything that I asked and the rest of Howland Park people that I have talked to had the same concerns that you addressed. I'm happy with what you have done and appreciate it.

**Supervisor Tollisen:** I will just note that before the Board makes a final decision, the Board is waiting for a decision from County Planning and also from the fire department.

**Councilman Wasielewski:** Mr. Hoyt, and just for the record, the pictures that you handed up to the Board, it is safe to assume that those conditions in the pictures don't exist today correct?

**Mr. Hoyt:** Well, I would hope not.

Councilman Wasielewski: I'm just double checking and want it to be clear.

Mr. Hoyt: Yeah

**Supervisor Tollisen:** Just so we are clear, I wasn't here when Prospect Meadows was being built and under construction. I can assure you that the Planning Department has a storm water management plan in place and it is followed to the T. If at any

time there are any issues we ask that they be addressed immediately. Our Director/Coordinator of Planning, Zoning and Code is here this evening and I will tell you that anytime one of these matters comes up, they are addressed immediately. While I don't expect any issues, I am glad that we have these so that we can learn from them, but on the same token, I believe that we have made leaps and bounds so that these things don't happen, including having a couple of storm water swat tours during the year to look at all of the projects that we have going on in the town.

Mr. Hoyt: Can I get an explanation why these cluster homes are so close and you don't think that the larger houses would sell better than living 5' away from another home?

**Joel Bianchi:** We offer 3 different housing styles, the larger Estate lots, Townhomes and Cottage homes. There was no rhyme or reason why, it's just the way we lined them out. It has been shown that this combination of homes sells well for all stages of homebuyers.

Erin, 201 Farm to Market Road: How far is the back of them from our property line?

**Joel Bianchi:** We moved the trails away and now there is a gap with open space and there is 15' - 20' from the back yard to the property line. These properties don't abut to you.

**Erin:** Could it be flip flopped potentially and that would put a lot of people up against our property

Joel Bianchi: I really don't think that you are going to get much of a change.

**Erin:** The other question I have is the traffic on Farm to Market. That is still a big issue that I feel still hasn't been addressed. There is going to be another 200 or so more cars on the road every day.

**Supervisor Tollisen:** Anyone else?

**Duane Hoyt, 201 Farm to Market Road:** I was wondering why this many houses on such a small parcel? I was wondering if you could break that down for me. I feel that it is too many lots to be packed on such a small parcel of land and a continuation of overcrowding such as in Clifton Park.

**Joel Bianchi:** We are proposing 91 lots on 95 acres. Obviously, we want to try to get as many lots in there as we possibly can and honor the constraints that we have to adhere to.

**Duane Hoyt:** The Trail system is a joke. They put in trails but they don't maintain them.

**Supervisor Tollisen:** What trail system are you referring too

Mr. Hoyt: Over in Summit Hills

**Supervisor Tollisen:** They are maintained by the town Park's Department. Thank you, we will look into that.

**Shelby Hoyt,** 205 Farm to Market Road: There was an archology dig that we have been witnessing on this property for the last couple of days, have you gotten any results back from that as to what they found or if it affects any of the building plans?

Joel Bianchi: We have not. It is probably about a month or so away

**Shelby Hoyt:** Would there be any findings that would stop this project?

Joel Bianchi: It would be highly unlikely that we would find archeological resources by certified archeologist; they coordinate with the State of New York. If we had too, we would call to the level of Phase II which would be pin pointing the resources of any value to the state to preserve it if there was any need to preserve it. It would probably be removed from the site and preserved in the state archives. There is not a pattern of that in the area and based on that, it is not near a water resource which is what triggers archeological resources.

**Shelby Hoyt:** And just going off what Duane had said about the number of homes, I understand that you are within the standards of the town and everything, but you don't live on that road and see the traffic that we do and would like for you to take into consideration that with that many homes it would be better for the original plan of the 74 homes and not the 91 homes. It will matter to us for the rest of our lives with the traffic and the people inconveniencing us on our property. The trails, again, they aren't maintained. The ATV's come through our property to get to other trails and ruin our crops and property.

Supervisor Tollisen: We will be looking into that. Thank you very much.

**Dan Hoyt:** I know that the whole parcel is 98 acres, can you tell me how many acres that is useable

**Joel Bianchi:** Without getting exact numbers, out of the 98 acres roughly 65 acres is useable. That is excluding wetlands, retention ponds, roads and sidewalks.

**Councilman Hotaling:** What is the density per acre?

**Joel Bianchi:** This proposal actually has more open space. I think that we increased the open space from the prior plan about 10 acres. That was a combination of useable open space and plain open space.

**Supervisor Tollisen:** Hearing no more comments from the Board or the public I'll close the public hearing at:

Anyway, I live on McBride Road and water already passed us over to go to the other developments and if this alleged pipeline goes through down Pruyn Hill and the other part goes down Johnson Road to the other developments so are left out which in my opinion is unfair.

I am here to petition the Town of Halfmoon that if there is any new construction that they take the residents on McBride Road into consideration and run a natural gas line down to us. It wouldn't cost too much all things considered. Also a lot of us since we don't have natural gas have to use other means to power our houses that can become rather costly. A lot of people got pretty mad when McBride Road got passed over for water and I still do not know why that happened and again there

are developments right there that do have water. I am just here to petition the Town of Halfmoon that if there is any new construction that they take the residents on McBride Road, we are taxpayers and we want it. So thank you very much.
