PUBLIC PRIVILEGE (for discussion of non-agenda items)

Larry Koniowka, 15 New Castle Road: I was wondering if the town was aware that in our neighborhood of Northwood Development, that there is a State run Elderly Home, Elderly Special Needs Care, that is being turned into a troubled home for teens, in a development that has a lot of kids and a lot of elderly Senior Citizens in there, not to mention, a lot of families. They moved in one troubled teen already and the police have already been there a few times. We don't know anything about this. There was a rumor going around the neighborhood that it might happen, and then all of a sudden now it is happening. We don't know anything about these kids, what their troubles are, we support helping troubled teens, but in a neighborhood like we've had, we've had no trouble at all with the elderly special needs people there. They were great! Buses would come and take them here and there, but now I've had multiple people come up to me and ask me if I knew anything about it and if I could address it, because they know that I come here on a regular basis.

Supervisor Wormuth: I would like to ask Councilman Hotaling and Councilman Polak if they have seen anything come before

Councilman Polak: There haven't been any changes of uses that I am aware of.

Supervisor Wormuth: Larry, do you have the address?

Larry Koniowka: 6 Cambridge Lane

Supervisor Wormuth: We will look into it and see which State Agencies are licensing and see if there is any authorization that the town has to do and we will get you an answer.

Larry Koniowka: OK, thank you.

Supervisor Wormuth: If you want to call my office early next week, we will have looked into it by then and try to figure it out. We will have an answer for you by the next Town Board Meeting.

Larry Koniowka: Thank you very much. The second thing that I have is a few months ago I spoke here about the scheduling of public hearings. They always seem to be at the following meeting and the minutes for that public hearing are always voted on that day of the public hearing, where the public does not have a chance to review the minutes. Is there any way that we can at least push it out a second week or after the minutes are actually posted so that people could review the minutes and prepare themselves for the public hearing, because they seem to be voted on that day and no one really gets a chance to see them.

Attorney Murphy: This issue has actually come up in the Zoning Committee meetings, and we are having one tomorrow, as far as trying to more effetely make sure the public has the notice it needs and the information it needs. So we are looking into exactly that. We will be addressing that issue tomorrow.

Larry Koniowka: Very good, thank you very much.

Supervisor Wormuth: The other thing that took a little bit to catch up is to stretch out when applicants to apply and actually appear on the agenda in order to get more public notice out.

Larry Koniowka: Thank you

Deanna Stephenson, 7 Cindy Lane: I am sorry that I am piece mealing these questions about zoning, but every time that I walk away, I have more questions.

What I heard tonight in the pre meeting prompted another question. There is no budget for the Zoning Review Committee at this point, correct?

Councilman Polak: Correct

Deanna Stephenson: OK, so

Supervisor Wormuth: We have money left in our General Engineering fund, which is a budget line item. We also have money left in the Planning Department based on vacancies that we can have which is why the Board looked at taking it on now and not putting it off or having to amend the budget at this point. We still have contingency in our budget as well. So well there is not a specific line item for that in the 2013 budget, if we hadn't taken that on yet, there is money available to pay for the work that we are doing now.

Deanna Stephenson: Ok, so that goes to my next question. Would CHA, are they doing any pro bono, or are they being paid, what I heard tonight, I think that they are being paid for any work that they are doing for this correct?

Supervisor Wormuth: We pay them for any engineering work that

Deanna Stephenson: Alright, no pro bono?

Supervisor Wormuth: No

Deanna Stephenson: OK, and my other question, and I just want to understand, when I read, Councilman Polak, you are a voting member of this committee?

Councilman Polak: Yes

Deanna Stephenson: OK, I am just throwing it out there, even though you are a Councilman, you are on the committee, as I put forth, would it have been better maybe to have one of the people that you have as the non-voting members to be a voting member rather than yourself only because, I'm just throwing it out there

Councilman Polak: That is the way that we have done it in the past that is why I continue that procedure.

Deanna Stephenson: OK,

Attorney Murphy: So that you are aware, most of the State Statuary Boards that are set up with require there to be a voting member of the Town Board as a voting member, so it's just kind of in accordance with what is established per state law.

Deanna Stephenson: OK, I was just looking at how this might, OK thanks.

There being no further business to discuss or resolve, on a motion by Councilman Hotaling and seconded by Councilman Wasielewski, the meeting was adjourned at 7:18 pm.
