WHEREAS, it has come to the attention of the Town Board of the Town of Halfmoon that the Baker family will celebrate their 150th anniversary of the Baker Family Reunion on August 9, 2014 at the Shenantaha Town Park in the Town of Malta; and

WHEREAS, the Board wishes to recognize the Baker Family Reunion as it is one of the oldest continually meeting family reunions in all of America beginning informally in 1862 when the sixteen sons of James Baker, who lived in Stillwater, began getting together annually until 1865 when the event became a recognized as a formal full family reunion; and

WHEREAS, the Baker family and their descendants have contributed so much to our local community throughout the 150 years in our area; and

WHEREAS, the Halfmoon community, and the communities around us benefit greatly from the Baker family's service to our community; and

WHEREAS, Spencer Cassedy, great grandson of James Baker, was a Justice of the Peace in the Town of Halfmoon beginning in 1933 following in the footsteps of his grandfather William Cassedy who served as a Halfmoon Justice of the Peace for thirty years. Spencer Cassedy was elected Town Supervisor of the Town of Halfmoon in 1937 thereby becoming a member of the Saratoga County Board of Supervisors resigning in 1947 to become the Auditor for Saratoga County where he continued until 1955 when he became the Commissioner of Jurors for Saratoga County. Beginning in 1953 he was also the Secretary Treasurer of the Saratoga County Mutual Fire Insurance Company all the while being very active in the 4H division of the Saratoga County Cooperative Extension; and

WHEREAS, this Board recognizes the importance of remembering our history while looking forward to the future as a community;

REPORTS OF BOARD MEMBERS AND TOWN ATTORNEY

Daphne Jordan: 1) Chair of Business and Economic Development, Chair of Insurance (Liability and Medical), 2) Liaison to Open Space and Trails Committee, (3) Co- Liaison to Zoning Board

The Open Space & Trails Committee: Short term project currently being worked on is for new signage for the Champlain Canal. The sign will be at the McDonald Creek Culvert and Halfmoon's Historic Waste Weir. The Halfmoon Waste Weir is the only visible waste weir with a culvert on the Old Champlain Canal System, so the signage will reflect that history. The sign is being purchased with grant money provided by the Hudson - Hoosic River Partnership.

As an extension of my role on the Open Space & Trails Committee, I am now also the Town representative for the Mohawk Towpath Scenic Byway Coalition and I attended my first meeting for that in July. The Byway is a series of local, county and state highways that follow the historic route of the Erie Canal between Schenectady, Cohoes and Waterford. In following the Byway, you could see how the Mohawk River and the Erie Canal and the communities along the way, Halfmoon being one of them, played a role in the westward expansion of our country and also the Industrial Revolution. The Byway Coalition itself is a not for profit consisting of representatives from each of the ten municipalities along the way and oversees the implementation of the corridor management plans. So I look forward to serving on the coalition for Halfmoon.

The Business & Economic Development Committee is continuing its work in identifying parcels of land in commercial and industrial zoned areas in town. We are examining very closely the industrial land within the town that lie along the railroad tracks and looking at what businesses that may want to partnership and use that land along the railroad. A resolution on tonight's agenda also comes with a strong recommendation from the Business & Economic Development Committee and that involves the Towns membership renewal with SEDC, Saratoga Economic Development Corporation. Dennis Brobston, the President and Jim Angus the Vice President of SEDC, who are members of the Business & Economic Development Committee and attend the meetings, are essential ingredients in the Towns recipe

for the successful attraction of new industry. I know that my fellow Town Board Members are in agreement with this and we look forward to our membership renewal with SEDC. I could keep going on but I will end it here for this evening. Thank you.

Supervisor Tollisen: Just a quick couple of items from me. **Linden Village**, we held a public hearing at the last meeting. There will be no action taken on Linden Village tonight. We are still waiting for comments and responses from our Town Attorney's with respect to the comments made by the public at the last meeting.

I am requesting the Board to make a resolution for **Fred's Tents** which was approved by the Planning Board. It is a business that manufactures tents for all over the world. The Planning Board approved it to be in the Yankee Dollar site on Hudson River Road. They are making an application to the IDA. Jim Angus had sent Miss Jordan and me an email today looking for the town's support of that. I did let him know that the Planning Board did approve it and they are looking for a

Town Board Resolution for support of him moving from the Town of Stillwater to a bigger facility in Halfmoon. There was also a consideration that he would move to Montgomery County and they are looking for some help from the town with a letter of support for Fred's Tent's moving into The Town of Halfmoon.

Supervisor Tollisen: With respect to the Town Budget, I promised that I would keep you updated on it. The mortgage tax for the 10th month in a row is below the projected amount budgeted. I have met with several departments and I have made cuts in several areas in the budget for the remainder of the year. We are going to continue to monitor that. I am very critically analyzing the Town Budget and the finances of the town. The spending freeze will continue for all town departments. I will continue to make cuts where I can. I will tell you that there are a few items that are obviously out of my control and weather is the #1 issue. I can tell you that with our snow plowing and our salting budget, we had a number of events in the beginning of the year, which basically ate up about 95% of our budget. There are many things to look at and I have made some substantial cuts with the help and aid of our Highway Superintendent as well as some others areas too. I will continue to do that and make every effort to balance the budget.

Supervisor Tollisen: I know that there are some individuals here from Tupelo Drive. I do want to update you with respect to the drainage corridor. Yesterday, our Town Engineer Mike Blanchino, myself, the Sewer District Executive Director Mr. Cook and the representative from the Homeowners Association met and we now have confirmed that the property is in fact owned by the HOA. From this point, we have asked the HOA to take from Ponderosa Drive down through and remove some vegetation in that area and remove some of the vegetation that is lying in the stream and things of that nature. They are reviewing that. The second part of that is; the Town Engineers, Clough Harbour & Associates are sending two site inspectors out Monday to walk the entire drainage corridor. So you will be seeing people through there on Monday. The third component of that is, which really does not affect you folks in 13 Tupelo, but it does affect that particular area through 5, 7, & 9 Tupelo, the Sewer District did do a bunch of improvements to the drainage pipe in that area. They are hoping that the drainage area will improve because they were able to get out plastic bottles, trees and tree stumps, culvert pipes and some things of that nature. They are going to put that on their regular schedule to get that out so that can continue to improve that part of it.

PUBLIC COMMENT (for discussion of non-agenda items)

Charles Blue, 13A Tupelo Drive: Kevin, could your clarify on something that you said a few minutes ago about who owns the land and the creek?

Supervisor Tollisen: Sure, the drainage corridor is actually owned by the Mapleridge Home Owners Association. There was some question with respect to the Home Owners Association, that they didn't feel that they owned it. Since then we did some research. They actually provided their tax bill, and based upon the taxes they pay on it and the SBL numbers that we took off those bills, we were able to get copies of the deeds from Saratoga County and showing that it is actually owned by the Home Owners Association.

Charles Blue: Are you saying the land on the side of the creek they own?

Supervisor Tollisen: The drainage corridor in that area. I can show you the map. I am not sure if I have it with me, but I can show you what property they own.

Charles Blue: I am trying to understand. They own the land but they don't own the water right? They don't own the creek?

Supervisor Tollisen: The water is included in the property that they own. That drainage corridor is

Charles Blue: So we can just dam up that creek?

Attorney Murphy: I think what he is talking about is riparian water rights, which are very different from land ownership, and that goes back to law before there was

law. You cannot, and I'm not 100% familiar with it, but you cannot dam up water that would interfere with someone downstream, is the basic premise of it. It is much more complicated than that

Charles Blue: So we don't own it then.

Attorney Murphy: You do own the land. There is a difference between a drainage corridor and the water in a drainage corridor and the ownership of the property. I am not going to give you hypotheticals but suffice it to say, but if you have further questions you should speak with an attorney as I cannot give you legal advice and I would have to do a lot more research on riparian water rights. That is my law school memory in having to deal with that.

Charles Blue: I will take your word for it. You said that there was a Town Engineer that was going to walk the creek and look at it.

Supervisor Tollisen: Actually, I got the email today that they are going to be sending out two inspectors on Monday the 11th. They will be starting at 8:00 in the morning. They are actually going to start at Brookview Court and work their way north towards the intersection of Ponderosa and Mapleridge Ave.

Charles Blue: This is the town person?

Supervisor Tollisen: The Town Engineers.

Charles Blue: Somebody came out already

Supervisor Tollisen: I was out there with the town engineer and the Highway Superintendent and a couple of other individuals two or three weeks ago

Charles Blue: This was 3-4 days ago.

Supervisor Tollisen: I do know that our Highway Superintendent was on site a couple of times walking through there trying to get some graphics and pictures. I do not know who that specific individual was. I do not know that answer.

Charles Blue: I guess my question is, can we sit down with somebody and see what they find?

Supervisor Tollisen: Yes, as soon as we have a summary report, I will be happy to share that with you and whatever information that we have. We had a very good conversation with the Home Owners Association. I guess the Association only has one Board member, but we had a very good conversation yesterday.

Charles Blue: Was that Susan?

Supervisor Tollisen: Susan is your agent. She wasn't there. It was Joe

Charles Blue: Lives on Oakleaf?

Supervisor Tollisen: Yes. We had a very good conversation. We are committed to finding some answers to that area. As soon as we have some information, I would be happy to share that with you.

Charles Blue: OK, thanks.

Deanna Stephenson, 7 Cindy Lane: I just want it on record. I was just concerned about 94 Werner Road. A few weeks ago, I do believe a developer took an existing barn, dug a big hole and buried the barn in it. I do understand that DEC did

approve of it, but saying that some archaic law about if you are on agricultural land, you were able to do that. I'm thinking that was an old, old law. If you had a barn on a lot of land and you want to take the barn down, you probably couldn't do it. Aesthetically, of course, it does look better. But I am concerned, you dug a hole, you put a barn in it that had glass, asphalt shingles, things that are just not good for the environment and you bury it. Even though DEC approved of it, I would love to know what DOH would think of it. I just want it on record, I am concerned about that and it is noted that the house next to where the barn was buried, the developer is trying to sell the house. I find that odd. I just wanted that on record. Thank you.

Supervisor Tollisen: I will refer it this to Code so they can look into it.

Deanna Stephenson: I think Code is aware of it and did reach out to DEC.

Supervisor Tollisen: I will make a formal note of that information.

There being no further business to discuss or resolve, on a motion by Councilman Hotaling and seconded by Councilman Wasielewski, the meeting was adjourned at 7:40 pm.
