WHEREAS, a certain owner of the abutting property has applied for an abandonment of said highway, and WHEREAS, the owner of all the abutting land thereto has consented to an abandonment thereof, and

WHEREAS, an abandonment is proper and will not cause injustice or hardship to the owners or occupants of any lands adjoining said highway or the public or residents of the Town of Halfmoon,

WHEREAS, a public hearing was held before the Town Board of the Town of Halfmoon on June 3, 2010, and no one from the public commented on the proposed abandonment,

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

That portion of the temporary turn around off of Saville Row described herein and made a part hereof as Exhibit "A", being an unimproved street, be, and the same hereby is, abandoned at the request of John Pingelski, Superintendent of Highways in the Town of Halfmoon, and at the request of the abutting property owner, is to proceed in accordance with and to mark on the official highway map of the Town of Halfmoon, the abandonment of said portion of the roadway which is hereby consented to.
