The October 17, 2018 Regular meeting was called to order at 7:00 pm by Supervisor Tollisen in the A. James Bold Meeting Room at the New Town Hall with the following members present:

PLEDGE OF ALLEGIANCE and MOMENT OF SILENCE

PRESENTATION: HALFMOON HEALTHCARE CAMPUS

Cathy L. Drobny, Deputy Town Attorney recused herself

Kevin Dailey and Larry Boni, the owner of the property: Good evening. Many of you on the Board and especially you Paul have seen this project before. This project actually started in 2005 and we have made continuous attempts to bring in different health care components to the Town of Halfmoon, and have not been successful. In 2012, St. Peter's has a press conference here and then a couple of months later said that they did not have any money. We have a lot of Urgent Care Facilities which are great unless you have a serious health problem.

We have felt in the growth of our Southern Saratoga County community and our population continues to grow. It has always been our opinion that we need more health care close by to where the people are. We have always run into resistance with the DOH who has a policy of that they would like to funnel everybody from our communities to hospitals in the inner cities which are failing institutions financially and run with a socialist intent. I can't say that that serves as the best interest of the people in our community who should have better health care than what they are being provided by these large hospitals.

So, that is the background. In the past we have had three strong possibilities that we have actually gone to contract and the Town Board is familiar with those.

- Memory Care Facility with 130 beds
- Senior Housing with components for continual care

We understand our community; Ellis Hospital could not see past the Northway and the Albany hospitals cannot see any farther north than Loudenville. But, we are not ever going to give up and continue to work to get something established at this location. I want to say thank you to the Town Board for continuing to extend the PDD. What we would like to do is ask for:

- An additional use to be added to the PDD to allow for Senior Citizen Housing
 - \circ We would then go to the Planning Board with a Site Plan Application
 - Each Site Plan Application that we come in with we need to come back to the Town Board especially with Bio-Medical research activities, you would want some input on that
 - The PDD is structured differently than it was in the past as we haven't come up with specific lots, layouts & number of units because we don't know how big the building will be, the parking requirements or what the need for town services will be. We will need to come back here for each aspect of this.
- To request an additional one year extension on the expiration date of the PDD, this would cover us to the next year.

Supervisor Tollisen: Any questions of the Board?

Councilman Wasielewski: Thanks, Mr. Dailey. I am glad to see that something is moving forward with project and a few of us had a bit less gray hair form when this was first presented. Do we have any idea how many beds we are talking here?

Kevin Dailey: Our immediate goal is to build two buildings, getting one building established first with 110 beds and then come back for a second building for the same use for an additional 110 beds. Along with that, there are parking concerns and there would need to be a traffic study. Seniors do not have as many trips as say a doctor's office, but these are the balances and checks that we look at going forward.

Councilman Wasielewski: Do you have any idea, are we looking at independent living, assisted living, skilled nursing, memory care?

Kevin Dailey: We are looking at independent living right now. We would like to come back if we get the first two established and revisit that memory care facility as perhaps a third building. We had told the Town Board that we wanted to retain 225,000 square feet for medical uses; doctor's offices, clinics and we are able to do that. We haven't taken anything away from what we originally told the Town Board what we wanted to do or what our intentions were. We have enough square footage for both of the buildings that we would like to add.

Councilman Wasielewski: So for the purposes of tonight, we are looking to add 110 independent living units plus an additional 110 independent living units.

Kevin Dailey: Yes.

Councilman Wasielewski: Because earlier you mentioned something about people with medical needs which could be assisted living or could be skilled nursing

Kevin Dailey: With the language that we have, it gives us a lot of room to maneuver in terms of filling a need in the community, but we are not being pinned down to any particular individual use

Councilman Wasielewski: I understand that. Those different levels of care would affect things such as parking spaces, size of buildings and things, that is why I am asking

Kevin Dailey: We understand that. By the time that we get to the Planning Board, we would have a much more specific request. Ultimately, we would have to come back to you for approval anyway.

Councilman Wasielewski: OK, thank you.

Supervisor Tollisen: Could you explain your public benefit?

Kevin Dailey: The Town of Halfmoon is still growing and people are aging. The town does have some senior housing but it certainly doesn't have enough for the population that is coming into its senior years. This particular type of housing fills a housing need in the community which will become acute within the next decade or so. We feel that in of itself is a tremendous public benefit.

The second public benefit is that it does allow us to get going with the medical campus. And having a medical campus and the services ultimately in the Town of Halfmoon is a tremendous public benefit to the citizens not only of the Town of Halfmoon but for the entire southern Saratoga county community.

Councilman Wasielewski: I have one additional question. Mr. Dailey, do you anticipate these units to be sold to the residents or will it be a monthly rent?

Kevin Dailey: This would be a monthly rental.

Councilman Wasielewski: OK, thank you.

REPORTS OF BOARD MEMBERS AND TOWN ATTORNEY

Kevin J. Tollisen (Town Supervisor)

I have a couple of things to discuss this evening and #1 is in regards to the Town Budget, the Town Board has before it the Preliminary Town Budget. Just to give some budget highlights

- 40th consecutive year that there is no general fund town tax to be levied on the residents of Halfmoon
- It includes a raise of \$1,750 for employees. This raise is intended to compensate for the increase in minimum wage that happens yearly and that our state government imposes on us yearly.
- It takes into account expected sales tax to increase. I will tell you that our sales tax that we use for numbers is a very conservative number.
- The town is not going to be relying on any unappropriated fund balance in either the general fund or the highway fund. The water fund will use \$100,000 of fund balance to pay the final settlement to the Town of Waterford.
- The general fund portion of the budget has increased by 3.39%m from the 2018 adopted budget. The Highway portion of the budget increased by 4.3%. The water portion of the budget of only a minimal increase of about \$20,000 from the prior year.
- The town budget increased from 2018 to 2019 overall is 2.31%. We are within the tax cap and we have run those tax cap numbers and the calculation that we have includes a growth factor in it and we are not even close to the tax cap requirement.
- It includes needed services for town residents; for over 1,000 seniors. Our Senior Center includes our Program Director and two assistants, Meals on Wheels, nutrition programs, the senior express vans and busses to transport our seniors to medical appointments and other needed assistance without any costs to our seniors.
- For our youth, we have our recreation program and you can see throughout the year, the number of different town events including the Trunk & Treat coming up.
- We also partner up with several Not for Profit Organizations: CAPTAIN, Center for the Family, and CareLinks. We support these programs because they are so essential to our community, providing much needed education, for financial, emotional and physiological support to those residents in need.
- We continue to aggressively pursue and secure federal, state and other grants for much needed projects for roads, sewer, water, parks, trails, recreation and court projects. A lot of the grant funding that we have received has made the town move forward in a very positive direction. If we did not have the funding, we may not have been able to get these projects done. So grant funding is essential and a very important component that we have. I can tell you that we have gotten grant funding for a portion of our water project and connection to the Saratoga County Water Authority, approval from NYS DOT for improvements to Sitterly Road. Next year will be the construction of the Sitterly Road turn lanes on the corner of Woodin and Sitterly. During this past year we have done improvements to Sitterly including the turn lane at Route 9 and Sitterly and an improved red light.
- Our town books are audited each year by a private, independent CPA firm. I will note that there have been no issues with respect to the town's financial statements. We continue to have a very strong bond rating, an AA3 designation rating. Some of the comments that are included in this bond rating: "Halfmoon has a robust financial position which is the strength with respect to the assigned rating of AA3. The town's cash balance is a percentage of operating revenues significantly above the US median and our operating revenues are on par with other cities nationwide."

Our town continues to have a very good financial position. We continue to put money in the bank. We continue to improve needed services. The difference between the tentative budget and the preliminary budget is just a few items:

- The Senior Dispatching is being moved out of the Highway Department and is going to be taken over by the Town Clerk's Office starting in January. We have moved that revenue stream into its own line item, for Aging Projects.
- We have increased the budget for the town computers in the IT Department for some needed updates to our computer software next year.

Other than that, the budget is pretty much the same as the tentative budget. There will be a resolution this evening requesting to schedule a public hearing on that. I will also note that we recently did a survey audit with our insurance. NYMIR is our insurance carrier. They have come and evaluated our facilities and our buildings, and I am pleased to note that the Town Board who has received a copy, the risk manager wrote a note to the town stating: "We are pleased to announce that there are no recommendations for changes at this time." All in all, the town is running in my opinion at a very efficient and proper level, our budgets are balanced, we seem to be putting more money in the bank, and making sure that our residents needs are being addressed.

Paul Hotaling (Deputy Town Supervisor): (1) Chair of Town Infrastructure (Water, Highway, Building & Maintenance), (2) Chair of Recreation and Character Counts, (3) Chair of Personnel Committee, (4) Chair of Safety Committee

As of October 15th, the water has been shut down for the year. Also, the 2nd Annual Trunk & Treat will be held Saturday with a lot of different things added this year. It should be a great time!

I would like to remind residents that Fire Prevention Month is continuing in October. Every fire company has had Open Houses and this coming Sunday there will be a Pancake Breakfast at the West Crescent Fire House, always a good time and it is good to support our local fire departments. In the spirit of fire prevention, in addition to their school visits they are also having a number of Halloween Parades in different neighborhoods throughout the town. I urge motorist to be careful with these slow moving parades with the kids running around. Safety first and on that note, Trunk or Treat is a great place for children to get their trick or treats in a safe way! Thank you.

Daphne Jordan (Town Board Member): (1) Co-Chair of Business and Economic Development (2) Animal Control (3) Liaison to Open Space and Trails Committee, (4) Zoning Board Liaison

I just wanted to announce that the town received from Saratoga County an additional \$10,000 to go towards the construction of the Vosburgh Preserve. That is in addition to the \$10,000 grant that we previously received that was initiated by the Trails & Open Space Committee.

Also, businesses continue to open in Halfmoon and today I attended the ribbon cutting at Lincoln Rugs in St. John's Plaza. So, if you need an oriental rug, pillows or some nice Turkish towels, you can find them there.

The Saratoga Wood Burner No.4 was patented in 1858 and made at the Crescent Foundry on the banks of the Mohawk during the Erie Canal days! It's a great story.

We are thrilled that the owners of a private collection of Civil War artifacts have allowed us to display them in Town Hall for a short time. Please come and join us as we step back in history to a time when these artifacts were everyday items, Lincoln was President and some very interesting stories to tell!
